### 8. Ordinance No. 126-06 - 3rd Reading - Ordinance, Rules & Claims

An ordinance establishing the zoning classification of GB-B, General Business B, as specified by Ordinance No. 50-03, Zoning Ordinance of the City of North Canton, for the premises known as the Chambers/Pittsburg Annexation, containing 4.815 acres of land, more or less, annexed by Ordinance No. 73-06.

### 9. Ordinance No. 127-06 - 3rd Reading - Water, Sewer & Rubbish

An ordinance authorizing the Mayor of the City of North Canton, through the Board of Control, to enter into a contract for the East Maple Well #9 Improvement project, at a cost not to exceed \$96,000.00.

# 13. Ordinance No. 137-06 – 1<sup>st</sup> Reading – Finance & Property

An ordinance amending Ordinance No. 145-04, as amended, Income Tax Ordinance of the City of North Canton, specifically Paragraph F, under Section 4, Article III-1, RETURN AND PAYMENT OF TAX, and repealing all legislation inconsistent herewith, and declaring the same to be an emergency.

# 14. Ordinance No. 138-06 - 1st Reading - Finance & Property

An ordinance providing for the issuance and sale of bonds in the aggregate principal amount of \$4,500,000 for the purpose of paying costs of improving and expanding the municipal waterworks system by (a) rehabilitating and improving an existing water tower, together with all incidentals and appurtenances thereto and (b) constructing, installing and replacing certain waterlines, together with all necessary appurtenances thereto, and declaring an emergency.

### 15. Ordinance No. 139-06 - 1st Reading - Finance & Property

An ordinance declaring that certain Sublicense for an E-Snychronist Business Retention and Expansion software program owned by the City of North Canton, Ohio, is no longer required for municipal purposes and has no monetary value; and authorizing the Mayor of the City of North Canton, through the Board of Control, to make a donation and/or transfer of said Sublicensing software program to the North Canton Greater Chamber of Commerce, and declaring the same to be an emergency.
