OLD BUSINESS

8. Ordinance No. 4-06 – 3rd Reading - Street & Alley

An ordinance authorizing the vacation of all of West Bachtel Street SW from the east line of Hillcrest Avenue to the west line of Fair Oaks Avenue SW, located within the corporate limits of the City of North Canton, Ohio.

9. Ordinance No. 5-06 - 3rd Reading - Street & Alley

An ordinance authorizing the Mayor of the City of North Canton, through the Board of Control, to enter into an Easement and Right of Way Agreement with American Electric Power ("AEP"), granting and conveying a right of way and easement "Easement" for electric, other energy, or communication purposes for current and/or future uses, the following described lands being known as Lot No. 6686 and 6685 situated in the City of North Canton, located in Section 8, Township (Plain) 11N, and Range 8, as defined by a map on file in the office of the City Engineer.

10. Ordinance No. 8-06 - 2nd Reading - Ordinance, Rules & Claims

An ordinance authorizing the Director of Law of the City of North Canton to prepare a petition to be filed with the Stark County Board of Commissioners for a change of township lines in order to make them identical, in whole or in part, with the limits of the City of North Canton.

18. Ordinance No. 21-06 – 1st Reading – Street & Alley

An ordinance authorizing the Director of Administration of the City of North Canton to advertise and receive bids according to specifications now on file in the office of the Director of Administration; and for the Mayor of the City of North Canton to be authorized, through the Board of Control, to enter into a contract for the Bonnett Street SW and Lynhurst Circle SW Improvements project, at a cost not to exceed \$845,000.00, and declaring the same to be an emergency.

19. Ordinance No. 22-06 - 1st Reading - Street & Alley

An ordinance authorizing the Director of Administration of the City of North Canton to advertise and receive bids according to specifications now on file in the office of the Director of Administration; and for the Mayor of the City of North Canton to be authorized, through the Board of Control, to enter into a contract for the McKinley Avenue Improvements project, at a cost not to exceed \$580,000.00, and declaring the same to be an emergency.

20. Ordinance No. 23-06 - 1st Reading - Street & Alley

An ordinance amending Section 3. of Ordinance No. 142-05, as amended, for the 9th Street NE/Orchard Avenue NE/Overland Avenue NE Improvements project, by an increase in the allocation, in an amount not to exceed \$749,000.00, and declaring the same to be an emergency.

21. Ordinance No. 24-06 – 1st Reading – Water, Sewer & Rubbish

An ordinance authorizing the Director of Administration of the City of North Canton to advertise and receive bids according to specifications now on file in the office of the Director of Administration; and for the Mayor of the City of North Canton to be authorized, through the Board of Control, to enter into a contract for the Summit Street Waterline Project, at cost not to exceed \$110,000, and declaring the same to be an emergency.

22. Ordinance No. 25-06 – 1st Reading – Water, Sewer & Rubbish

An ordinance authorizing the Director of Administration of the City of North Canton to advertise and receive bids according to specifications now on file in the office of the Director of Administration; and for the Mayor of the City of North Canton to be authorized, through the Board of Control, to enter into a contract for the Cordelia Street SW Waterline Replacement project, at a cost not to exceed \$205,000, and declaring the same to be an emergency.

23. Ordinance No. 26-06 – 1st Reading – Water, Sewer & Rubbish

An ordinance authorizing the Mayor of the City of North Canton, through the Board of Control, to enter into an amended professional services agreement for additional construction and inspection services for the Backwash Holding Tank/Generator Project, as authorized per Ordinance No. 87-05, at a total cost not to exceed \$77,000, and declaring the same to be an emergency.

24. Ordinance No. 27-06 – 1st Reading – Finance & Property

An ordinance authorizing the Director of Administration of the City of North Canton to advertise and receive bids according to specifications now on file in the office of the Director of Administration for one (1) Ladder Truck, for use by the Fire/EMS Department, at a cost not to exceed \$750,000; and for the Mayor of the City of North Canton to be authorized, through the Board of Control, to enter into a lease-purchase agreement for said Ladder Truck.

25. Ordinance No. 28-06 - 1st Reading - Finance & Property

Ordinance No. 28-06 authorizing the Mayor of the City of North Canton, through the Board of Control, to enter into an amended contract by and between the City of North Canton and the Stark County Public Defender Commission, for the purpose of providing legal counsel to indigent persons in Canton Municipal Court, specifically Item 3 of the contract, Terms of Service, changing the duration of the contract to a period of one (1) year, and declaring the same to be an emergency.
