**8. Ordinance No. 11-02 - First Reading - Community & Econ. Dev.**

An ordinance amending Ordinance No. 2940, Zoning Ordinance of the City of North Canton, to change the zoning district of the three (3) acre tract of land situated on the south side of Applegrove Road N.W. and known as part of Out Lot 230, and further known as the Great Trail Girl Scout Council, from R-70, Residential, to OB, Office Building district.

**9. Ordinance No. 12-02 - First Reading - Community & Econ. Dev.**

An ordinance amending Ordinance No. 2940, Zoning Ordinance of the City of North Canton, to change the zoning district of a 10.718 acre tract of land situated on the south side of Applegrove Road N.W. and known as part of Out Lot 230, and further known as the North Canton Rotary Park, from R-70, Residential, to P&I, Park and Institutional district.
