NOTICE OF HEARINGS AND MEETING

Notice is hereby given that a public hearing will be held by the Council of the City of North Canton on Monday, January 9, 2006 at 6:15 p.m. in the Council Chamber at North Canton City Hall.

The hearing is with regard to a proposed amendment to Section 1107.05(e) and 1107.03(c) OPEN SPACE of the North Canton Zoning Ordinance.

The Planning Commission, at its November 9, 2005 meeting, recommended that the following definition be used for open space:

Section 1107.05(e)

Whoever subdivides under this chapter shall provide open space. A minimum of five (5%) percent of the gross area to be subdivided shall be provided and dedicated to the City. The open space shall be of usable size and shape for the intended purpose as determined by Council. Half of the five (5%) percent can be detention and/or retention basins.

1107.03(c)

The preliminary plat shall indicate the location and the intended use of the open space. The preliminary plat shall be presented to North Canton City Council at the same time as it is presented to the commission. Council shall approve the preliminary plat concerning the location and intended use of the open space after the commission approves the same.

Final action thereon, according to law, will be taken by the Council of the City of North Canton subsequent to the date of said public hearing.

Notice is hereby given that a public hearing will be held by the Council of the City of North Canton on Monday, January 9, 2006 at 6:30 p.m. in the Council Chamber at North Canton City Hall.

The hearing is with regard to a request to vacate Alley No. 9 from the south end of the alley and running in a northerly direction to the southern property line of Lot 930 on the west and the southern property line of Lot 938 on the east.

The North Canton Planning Commission, at their November 9, 2005 meeting, voted to approve the partial vacation of Alley No. 9 as described above.

An ordinance authorizing the Mayor of the City of North Canton, through the Board of Control, to enter into an Easement and Right of Way Agreement with American Electric Power ("AEP"), granting and conveying a right of way and easement "Easement" for electric, other energy, or communication purposes for current and/or future uses, overhead and underground, in, on, over, through, and across the following described lands being known as Lot No. 6686 and 6685 situated in the City of North Canton, located in Section 8, Township (Plain) 11N, and Range 8, as defined by a map on file in the office of the City Engineer.

19. Ordinance No. 6-06 - 1st Reading - Water, Sewer & Rubbish

Ordinance No. 6-06 authorizing the Mayor of the City of North Canton, through the Board of Control, to enter into a professional services agreement for the design of the Water Tower #2 Pump Station and Water System Improvements in the vicinity of Water Tower #2 Pump Station, and declaring the same to be an emergency.
