8. Ordinance No. 56-07 – 2nd Reading – Community & Economic Development

An ordinance authorizing an agreement with L.T. Parker & Associates, Inc. dba APARCO Security Systems providing for a project and real property tax exemption pursuant to the Ohio Community Reinvestment Area program.

9. Ordinance No. 57-07 – 2nd Reading – Water, Sewer & Rubbish

Ordinance No. 57-07 accepting a Water Utility Easement ("Easement"), by and between The Board of Education of North Canton City School District ("Grantor") and the City of North Canton ("Grantee"), through the property known as the Northwood School Waterline Interconnection, Parcel No. 5680250, part of Out Lot 273, located within the City of North Canton, Stark County, Ohio, necessary for the School Avenue Waterline project, and declaring the same to be an emergency.

23. Ordinance No. 79-07 - 1st Reading - Finance & Property

An ordinance authorizing the supplemental appropriation of funds of the City of North Canton, Ohio, to be appropriated from the unappropriated balance of the Income Tax Fund to the Refunds Account in the amount of \$120,000.00 for the current expenses during the fiscal year ending December 31, 2007, and declaring the same to be an emergency.
