8. Ordinance No. 56-07 –3rd Reading – Community & Economic Development

An ordinance authorizing an agreement with L.T. Parker & Associates, Inc. dba APARCO Security Systems providing for a project and real property tax exemption pursuant to the Ohio Community Reinvestment Area program.

Ordinance No. 83-07 accepting a Perpetual Storm Sewer Utility Easement ("Easement"), by and between North Canton Plaza, Inc. ("Grantor") and the City of North Canton ("Grantee"), through the property known as being part of the Southwest Quarter of Section 17, Hoover fka Plain Township, Range 8, Parcel No. 5608838, located within the City of North Canton, Stark County, Ohio, necessary for the South Main Streetscape — Phase IV Project, and declaring the same to be an emergency.

24. Ordinance No. 84-07 - 1st Reading - Finance & Property

An ordinance providing for the issuance and sale of \$925,000 notes, in anticipation of the issuance of bonds, for the purpose (i) of paying costs of improving City streets by reconstructing and rehabilitating certain streets identified in the City's Capital Improvement Plan and constructing curbs and gutters and related improvements, together with all necessary appurtenances thereto and (ii) paying costs of improving and expanding the City's sewerage system by constructing sanitary sewer lines, together with all necessary appurtenances thereto, and declaring an emergency.
