Ordinance No. 131-04 amending ARTICLE XVII, HOLIDAYS, Section 17.03, ARTICLE XIX, SICK LEAVE, Section 19.11, ARTICLE XXVIII, UNIFORM ALLOWANCE, Section 28.01 of Ordinance No. 7-04, Collective Bargaining Agreement between the City of North Canton and The Fraternal Order of Police, Ohio Labor Council, Inc. (FOP-OLC), and by the addition of ARTICLE XXXVII, DRUG TESTING, TO Ordinance No. 7-04, Collective Bargaining Agreement between the City of North Canton and The Fraternal Order of Police, Ohio Labor Council, Inc. (FOP-OLC).

NEW BUSINESS:

9. Ordinance No. 134-04 – 1st Reading – Community & Economic Dev.

An ordinance implementing the terms of Paragraph 5 of the Plain Township/City of North Canton Cooperative Economic Development Agreement and Annexation Agreement ("CEDA"), dated June 17, 2003, by establishing the zoning classifications of One-Family Residential, R-70, Two-Family Residential, R-50, Three-Multi-Family Residential, RMF-A, and Four-Multi-Family Residential, RMF-B, as specified by Ordinance No. 50-03, Zoning Ordinance of the City of North Canton, for the premises known as The Sanctuary Annexation, containing 107.4341 acres of land, more or less, annexed by Ordinance No. 120-03.

10. Ordinance No. 135-04 – 1st Reading – Community & Economic Dev.

An ordinance establishing the zoning classification of One-Family Residential, R-70, as specified by Ordinance No. 50-03, Zoning Ordinance of the City of North Canton, for the premises known as the Orion Street Annexation, containing 0.6065 acres of land, more or less, annexed by Ordinance No. 54-04.

11. Ordinance No. 136-04 – 1st Reading – Water, Sewer & Rubbish

Ordinance No. 136-04 amending Section 921.04, of Ordinance No. 75-94, as amended, of the Codified Ordinances of the City of North Canton for the purpose of increasing the fee for sewer connection charges.
