### 7. Recognition of visitors.

Mr. Foltz: Anyone who'd like to speak before Council, please come up to the podium and state your name and address.

Mr. Osborne: My name is Chuck Osborne. 307 Fairview Street, SE, North Canton, Ohio. On the agenda this evening, there are two (2) pieces of legislation that I would like to address. The first is Ordinance Number 59-06, which is legislation from the Community & Economic Development Committee. Tonight's agenda for this piece of legislation reads "An ordinance authorizing an agreement with Patrick J. and Georgann Palonder for a project and real property tax exemption pursuant to the Ohio Community Reinvestment Area program, and declaring the same to be an emergency." First of all, I have to ask why is this on emergency? Emergency legislation, according to Section 2.05 of the North Canton City Charter, is legislation necessary for the immediate preservation of public peace, health or safety. Where is the emergency? Fast-tracking legislation limits public comment. Corporate charity in the name of tax abatements is a topic that the public should be allowed to address. Three (3) readings would allow taxpayers notice of this legislation and given them a chance to comment. abatement of taxes for business that in exchange merely offer the businesses presence in the community might be a topic of interest to taxpayers of this City who must continue to pay taxes without benefit of personal abatements. The business requesting the abatement of taxes is the Pat Joyce Insurance Agency, which has operated in North Canton since 1980. Mr. Palonder states on the application that ... "without the tax incentive, we will sell the property and build in Jackson Township." The operative word here is "incentive." The property, according to the Stark County Auditor's website, was purchased September 9, 2005. The purchase of this property on North Main Street, next to the former Bank One building, evidently did not require an incentive; so, how can this be termed an incentive. The decision to purchase the property was made with plans to build on the property. Since that purchase decision was made over seven (7) months ago, any abatement of taxes is no longer an incentive but simply a handout at the expense of the North Canton City Schools. An incentive, by definition, is something that encourages someone to action. The purchase of property on North Main Street has already happened seven months in the past. Investment in Main Street properties is happening. It is happening without handouts that come at the expense of the taxpayers of the City and at the expense of the North Canton City Schools. Freemarket forces are alive and well on Main Street, and those free-market forces will continue to work unless disturbed with demands for more corporate welfare. The application by the Pay Joyce Insurance Agency states that it will add two (2) full-time jobs within one (1) year. I do not want to play down any job creation in North Canton by any business; but with the small numbers of businesses in North Canton, the abatement of taxes reduces the tax base. Furthermore, it places more of the tax burden on homeowners and directly impacts the North Canton City Schools. City services can best be supported when tax revenue is derived from a broad base - broad tax base of residential, retail, commercial and industrial properties. The tax base for North Canton is being whittled down with the loss of manufacturing and industrial property tax base from The Hoover Company - and now, ever so slowly, from the abatement of taxes on the few commercial properties that make up North Canton's commercial tax base. What remains are residential property owners supporting both the rising costs of City government and the increasing costs of the North Canton City Schools. To quote Repository columnist, Michael Hanke, in today's paper, "Do economic development supporters really believe real estate tax abatement is more important than a good school system to prospective employers?" To further paraphrase Mr. Hanke, does this Council believe that approving revenue cuts to the strongest asset that the City of North Canton has going for it - its City Schools - is a good idea? I hope in my heart that you do not believe that. And that brings to mind the timing of this requested abatement. I do hope that this Council is aware that the North Canton City Schools do have a levy on the ballot for next month. How can you stand up here one week and tell the public that you support the school levy and then the very next week give away revenue that's really needed to support the great school system that residents proudly enjoy. In light of the plight of the City's financial picture revealed by - revealed in Mayor David Held's State of the City Speech just last week, and in consideration of the voters who are being asked to vote for the North Canton City School levy in just a few weeks, I ask that this

Council seriously reconsider any plans to approve this tax abatement request. The second piece of legislation I want to speak to is Ordinance Number 60-06, which is legislation from the Finance & Property Committee. This legislation reads "An ordinance accepting the recommendations of the City of North Canton Tax Incentive Review Council ("TIRC") concerning the agreements granting exemptions from property taxation to continue the existing eight (8) Community Reinvestment Area ("CRA") agreements." This piece of legislation is not scheduled for passage on emergency, but for everyone in this room tonight, we all know that this will be amended to pass on an emergency. How sad that legislation such as this will be fast tracked before interested taxpayers can comment quickly - or publicly. I attended the meeting of the North Canton Tax Incentive Review Council on March 22, 2006, and I must say that the name of this group should be changed to the "North Canton Corporate Welfare Review Council." Three (3) of the eight (8) tax abatements that were reviewed have not met their promise of new or retained jobs as contracted when the abatement was granted. A member of that Tax Incentive Review Council, and also a member of City Council, Mr. Jon Snyder, appropriately described several of the troubling tax abatements that were reviewed at last week's Council-of-the-Whole meeting. The tax abatements that Mr. Snyder described last week were, indeed, troubling; and yet they were continued. And to make a mockery of the review process, it was made clear by the representatives from each of these three companies that there was a high probability that they would not achieve their promised goals in the foreseeable future. Why were the abatements of these companies not cancelled outright? At the very least, three companies should have been put on probation. The other companies reviewed only marginally met the requirements for their abatements as well. As I sat and listened to each of these three companies explain their plight, I could only think that this process of so-called tax incentives had degenerated further from corporate charity to corporate welfare. My last comment on the Tax Incentive Review Council is in regards to the membership of the committee. The practice of appointing Council members to serve on the Council undermines the system of checks and balances so important in our system of government. When a Council member also serves on the Tax Incentive Review Council, that Council member is quite possibly reviewing tax abatements that he or she approved as a Council member. This runs counter to the checks and balances so vital to the process of government. The practice of individuals serving as both Council members and as members of the Tax Incentive Review Council should end. In the same Repository column today that I referred to earlier, Michael Hanke states that "It seems that the only greater anti-school children group is the City of Green, which never met a tax abatement it didn't like...." I fear that North Canton is running a close second. I urge you not to seek to earn that sort of reputation. It will only harm our schools and our City. I have one final thing. I have a letter here for our new Law Director. Briefly, I am addressing this letter to request you, Mr. McFarren, that, in your capacity as the Law Director of the City of North Canton, you institute civil action on behalf of the taxpayers of North Canton against former City Administrator Mr. Michael Miller for the recovery of \$6,000.00 that was expended through neglect of duty by Mr. Miller for which the taxpayers of North Canton received nothing of value in return. And there's a little bit more to the letter, but I will end there and...(inaudible).

Mr. Snyder: Mr. President, if I may - and I hope my colleagues would endure it a little bit. A couple of things here: number one, relative to - and Chairman Repace, I

apologize if I made a comment on that, as I sit on your committee. Relative to the Palonder tax abatement – number one: the reason for the emergency is it is, in fact, to the welfare of the City. I believe there's some \$1,800 and some dollars in income tax that comes into the City from that site that we would lose. However, the abatement – even with the abatement, the City Schools are receiving greater funds than they are presently receiving from that property. And, contrary to Mr. Osborne's scenario, businesses do not pay taxes, whether you believe it or not. Businesses are passed directly through to the person who purchases the product. So, it doesn't actually – you're not taking a tax away from business by pushing – by giving him the tax incentive, because his expenses are pushed right in through his cost of doing business. But the \$1,800.00 we would lose in City income tax, as well as some \$1,600 and some dollars the school would have lost, because the property would have gone to Jackson. And Mr. Palonder is under a situation where if he doesn't begin building, he will leave. I spoke to him on Wednesday night, as the Mayor did and Mr. Wise and Director of Economic Development Bowles. And that was the reason that it was put on as an emergency basis. We followed all the guidelines. And one job or two jobs – I mean, we're just –

we're in a world, as he says, that's true. It's not easy there, unless we do something to keep our existing businesses or encourage new businesses, and that's the only incentive we have. It's either that or give away the income tax. And, obviously, we receive less on property tax, which is, I think, about .9 versus what we'd receive in income tax. So, that's the basis for that. And I don't know if Mr. DeOrio wants to speak to the other question or not. But I'll defer to him on that.

Mr. DeOrio: In regards to the – the Tax Incentive Review Council, yeah, I couldn't disagree more with Mr. Osborne on that. And, you know, it's, it's – we have a situation where we have some businesses that are on the cutting edge of whether or not they're gonna make it, and being that the agreements were just one (1) year old, I mean, you have to allow some time for them to ramp up and get to the point where they are going meet – or feel they're going meet the projections that they are. I mean, if – why draw, you know, Mr. Osborne's logic – why draw it at one year? Why not have it the first day? I mean, if you haven't met the CR – if you haven't met the TIRC recommendation on the first day, you're not in compliance. I think we were very reasonable. I think that the discussion that was there reflected that, and I'm very comfortable with the way we left that. So, that was my only comment.

Mr. Foltz: Very good. Anyone else like to address Council tonight?

Ms. Burnett: I'm Suzanne Burnett, and I live on Pierce Avenue in North Canton. And I'm a member of the Community Reinvestment Area Committee. And I would like to say that when we discussed the application for help from Main Street, it was our opinion that Main Street needs all the help that it can get. It is the main route through North Canton. If we do something to make Main Street look better, if we can improve real estate along that lane — that road that leads through our great City, it will be to our benefit, and I do not agree with Mr. Osborne in his assessment of our action. Thank you.

Mr. Foltz: Okay. Thank you.

Mr. Schilstra: Ken Schilstra. 601 Linwood. I assume everyone's had a chance to read the notice they were given from the EPA Citizen Action Alert. Do I see heads shaking? In typical fashion of the approach to get these things through, the EPA chose not to mail the information out until last week for a hearing that is day after tomorrow. And then there's an extended comment period after that. Also, if you - as and described you want to go see the documentation, there's only one (1) place to go, and there's only one (1) copy to be seen, and that's in Twinsburg. And you have to go there. You can't check it out. And it's somewhere close to - we recorded 500 pages. And you have to make an appointment to even see it. And you're in a room with a camera, and they watch you; you know, and so on and so forth. But, the little bit we've been able to deduce from this is guess what, folks? Some of this is in the Zimber water shed. It's coming this way. So, we've got more water. There's more going to, also off to, I think - it looks like the west. But, we've got more. And unless - first of all, I guess it's a done deal. They've cut the deals. They're gonna fill in Category 3 wetlands at the Airport which all - we all know. Remember Katrina? Those are absorptive functions. They also reduce, you know, the pollution and so on and so forth, associated with that. But, we'll end up with more runoff, and there's no plan to do storm water detention to deal with that. So, you guys are selling the water to the Airport. I think it's time to use some leverage. Thank you.

Mrs. Magel: May I ask a question, please.

Mr. Schilstra: Sure.

Mrs. Magel: I did get your -

Mr. Schilstra: I, I know everyone was given one. Mr. Foltz: Everybody has one in everybody's packet.

Mrs. Magel: Okay. It's a citizen advisory, and I think, maybe, you know I also have a public hearing coming April 25th.

Mr. Schilstra: Yes.

Mrs. Magel: Where did you get this?

Mr. Schilstra: We're on a mailing list. We got on – my wife got on the mailing list for the EPA for notifications.

Mrs. Magel: Did you, by any chance, get one for my meeting?

Mr. Schilstra: Nope. Not yet.

Mrs. Magel: Not yet, okay. If you do, would you please let me know?

Mr. Schilstra: We'll let you – we will – you will be the first to know. But, yeah, they kind of slip it out. And the first attempt to make an appointment to go see the documentation was – in about two (2) weeks it would be available to be seen. Well, the meeting is in five (5) days.

Mrs. Magel: Okay, and I take it you did go to Twinsburg and -

Mr. Schilstra: My wife went up today and got some of the information.

Mrs. Magel: Okay.

Mr. Schilstra: You're allowed to make 250 pages of copies.

Mrs. Magel: 200

Mr. Schilstra: and 50, I guess --

Mrs. Magel: Okay.

Mr. Schilstra: -- which you don't take all, you know. Haven't had a chance to review it

vet.

Mr. Foltz: That's of the 500? You said there's 500?

Mr. Schilstra: But if you go to 251, then you pay for the first 250.

Mrs. Magel: Now, this is concerning the water quality --

Mr. Schilstra: Yes.

Mrs. Magel: -- more than the volume.

Mr. Schilstra: They are not addressing the storm water retention at this point in time. That's puts you in the, you know, phrase of S.O.L., and we all know what that means. We're sure out of luck. But at this point in time, as far as we've been able to determine, and there's very little information anybody's willing to offer, they are not gonna deal with storm water detention. That comes later – after we've all had to deal with the problem.

Mrs. Magel: And do you know who requested this meeting?

Mr. Schilstra: The meeting on Wednesday? It's required by the Ohio EPA, and it also requires approval by the Army Corps of Engineers to fill in wetlands.

Mrs. Magel: Okay. This one was required, where I suppose mine was not required.

Mr. Schilstra: The other thing associated with it, in talking with some people we know who are inside the EPA, they said none of these have been turned down in the last five to seven years – for destruction of wetlands and maintenance of the quality. We get lip service to maintaining the headwaters of everything, and that's where they all start. But we're gonna fill them in anyway. Thank you.

Mr. Foltz: Okay. Thank you. Mrs. Magel: Thank you.

Mr. Foltz: Anyone else like to address Council?

Mr. Hershberger: Shawn Hershberger. 1320 South Main. I'm the owner of Café 1320, and I want to talk about the South Main project. I had – some whys and how construction – Eric just said that in a couple weeks we're having a meeting with the engineers, so I guess we won't need to address those issues tonight. My real concern is streetscaping – what it's really supposed to do for the City of North Canton. I notice

from Rose Lane going north - I don't know how long ago that happened, but I've only been in town for four (4) years. You've got sinking brick, chipping brick - which is a liability. We gotta go in and repair all that at one time. We're spending \$2 point some million dollars to do this project, and it's killing your South Main business people. I just don't understand. I don't know that I can survive it. You're taking out my entire summer season where I need to make my money to bank on for winter months when we don't do any business. I've got quite a few employees there. I built my business. That wasn't a very good restaurant when I bought it four years ago. You're taking up the entire summer months for this, and I don't understand why it couldn't be done in late fall, early spring, both, something. I had a very, very bad winter down there. Cost of goods are up fuel costs are up. All my vendors are charging a fuel stop charge. Jobs and Family Services fees are up - everything's up. I raised my menu to help cover that. I'm struggling. I will not survive. So, Brenda Capestrain, who owns the plaza that I'm in, We're at 50% occupancy now.

Ms. Capestrain: I don't own the plaza. I don't own the plaza.

Mr. Hershberger: She owns the dry cleaners in the plaza. We're in a plaza that's now at 50% occupancy, and the next one up's not doing any better. You've got Kraus' Pizza in there. The guy just opened. He's concerned about it too. He's trying to build a restaurant. And I'm not here to attack. I get myself all -

Mr. Foltz: Well, you're a business owner, and you're trying to make ends meet.

Mr. Hershberger: Absolutely. I'm not attacking or anything.

Mr. Foltz: We appreciate your comments.

Mr. Hershberger: We are so concerned you're going to take everything. I spoke to people at Ro's Ice Cream. They can't be here, because they gotta be down there runnin it. They're concerned that they could take a 50% loss of sales and employ 50% less people - all of these businesses - I don't think that by streetscaping from Everhard to Rose Lane is something that's got brick, and we have to go back ten (10) years later and re-do. It's not broken, so why are we fixing it?

Mr. Snyder: Mr. President, you better explain - we're not putting bricks into the sidewalks there.

Mr. Hershberger: Oh, you're not gonna do that from there down so it would match.

Mr. Snyder: We're only doing infrastructure work, see, so there is no streetscape from Rose Lane to Everhard. The poles will be moved from the west side –

Mr. Hershberger: You're putting in sidewalks?

Mr. Snyder: -- or from the east side to the west side. Yes. But we're not putting in brick sidewalks.

Mr. Hershberger: Okay. Which is a smart move, because, obviously, it didn't work.

Mr. Snyder: A lot of cost also.

Mr. Lane: Well, there'd be new light standards as well.

Mr. Hershberger: You're gonna still dig it up; it's going to be down to two (2) lanes; people are going to avoid those areas.

Mr. Snyder: The quality of the road, if you look at it, will not stand another winter. It's not done for aesthetic purposes. It's done because that road is sinking. And I was fortunate through Mr. Miller this past fall - last fall - to have it recovered from Maplecrest southwards to Easthill. But that road will not take another winter without collapsing. It is not done for aesthetic purposes. It's done for functional purposes. That road is corroding away from the bottom. It sits on concrete and brick -

Mr. Hershberger: Right.

Mr. Snyder: -- and needs to be taken apart and rebuilt; otherwise, you won't have a road to come to your business with. And they will maintain traffic - both north and

southwardly through the whole project - not like the project they're doing today. I lived through construction of South Main. I know exactly -

Mr. Hershberger: I understand the bridge. I do. I bought the story. We got (inaudible) ...for three (3) months to save money. It's a road that you could drive over that bridge and see the bridge is eroding. I don't see that our sidewalks are eroding.

Mr. Snyder: No, but the street is.

Mr. Hershberger: Okay. So, why don't we repave?

Mr. Snyder: We are going to. We have to rebuild the street. You can't just repave. The street is collapsing from underneath. The underlayment of that street is coming apart. That street is probably 80 to 100 years old. It has to be built properly. It's being done with federal funds to the specifications of the Federal Department of Transportation and O.D.O.T. (Ohio Department of Transportation). It's not a City project. It's a \$4,000,000.00 project funded only \$100,000.00 by the City. And it's done to their specifications.

Unidentified Speaker: How long, Jon? How long will it -

Mr. Snyder: It's a 200-day contract starting, probably, July 4th weekend; and, you figure, that's what? Three, four months. So, it will probably be, realistically, into September, the first week of October, provided there is no, you know, depending on the weather. The South Main Project, I think, the Mayor and Director Wise will tell you, is probably running about 12 days ahead of schedule. The problem is, I mean, there's no other time to do it. I mean, we're in northeastern Ohio. You have about a 250-day window where you can do construction. The materials have to be laid at certain temperatures. That's all governed by the government. So we have to --

Mr. Hershberger: I understand that. We have those temperatures in late fall and early spring.

Mr. Snyder: That's right. Now, I mean, as far as the ability to, I mean, I'm sure somewhere along the line - and trust me, I'm extremely sympathetic to your, your situation, because I've lived through construction. I know what it can do financially to any business.

Mr. Hershberger: I can't live through it. I know my financial situation right now.

Mr. Snyder: I'm sure somewhere along the line --

Mr. Hershberger: I have a sign, and I just want to know what you people think.

Mr. Snyder: Somewhere along the line, I will - I would ask you, and I'm sure the Mayor and Mr. Foltz will back me up as well as my colleagues. There's something that will be able to help minimize the situation - whether it's signage - what we're gonna have to do - allow some zoning variances or some other things for you to do, because the last thing we want to do is put you out of business. I mean, there's no possible way. That's not in the best interest. But, when it's complete, it'll actually enhance your business. It's a proven fact.

Mr. Hershberger: It hasn't kept - from Rose Lane up, it hasn't drawn business or kept businesses open. They're closing.

Mr. Snyder: Well, I don't know.

Mr. Hershberger: That beautification did not help. Norcia's closed. The rib shop. I mean, it's just - it goes on and on.

Mr. Snyder: I would beg to differ with you there. I was there seven or eight years after it, and I never, you know. I mean, did I ever get back exactly what I lost? No. I mean, it's a global market today, so I can't blame it on the construction.

Ms. Capestrain: Shhh. You're making me look bad. Brenda Capestrain. 1310 South Main Street. I have the same concerns. I'm not against the project. I didn't realize what Jon just said about the street, you know, eroding, or whatever – it needs rebuilt. I'm just very concerned as a small business owner for – in North Canton that – I'm in the same plaza with Shawn, and we struggle terribly for a number of reasons. The location of the plaza, itself, is not the best, and we have some – with a terrible sign out there and some shrubs – removal of the shrubs. So, if the guys want to tear that out, too, when they're doing the streets, we won't care. So, they can do that too. But, just, again, support of the North Canton businesses. My lease is up, here, end of 2006; and depending on what goes on for me as well. I'm struggling just as bad as Shawn. Unfortunately, North Canton with Hoovers – I'm an ex-Timken employee, so, you know, I know all about that. And I don't know where the money's coming from. Eventually, since there's no industry left here in the area, the small businesses are going to have to employ the young kids from Hoovers and Hoover High School and young adults. So, we hope to still be here to give them jobs. Okay.

Mr. Foltz: Thank you for your comments. The last thing we want to do as a Council body is to drive businesses away or to close them up. So, as Member Snyder indicated, telling about the infrastructure, it's just putting up with in a short term for the long-term gains, hopefully. And I know that intersection at Everhard and South Main's going to be wonderful – turn lanes – that you're going to actually increase traffic, hopefully, coming through North Main.

Mr. Lane: Mr. President, I know that Mr. Bowles, if you wanted to make a comment. He's been working with a lot of these folks, and we're planning a meeting here very soon

Mr. Bowles: Good evening. I just want to make Council aware that Mayor Held and I and the administration – we've had multiple conversations regarding the South Main. The concerns the businesses have been expressed to me. And, generally, if you've all heard me talk, the businesses in North Canton are not unlike other businesses in Stark County and other places in Ohio. It's been a very, very rough first quarter. I just want to let you know that – adding to what Shawn said – is we are planning a meeting with the South Main merchants some time within the next two (2) weeks. I've already had conversations with Councilman Lane and Councilman Snyder; and they've agreed to be at that meeting and also the City Engineer and the administration. We'll talk about a number of different opportunities to help lessen the effects of the construction and the timeframes and, possibly, some co-advertising opportunities to try to lessen the effects of the business. It won't, certainly, make up for the losses – possible losses during the construction. But, you know, the City and the administration – we're willing to do our part to help out.

Mr. Foltz: I appreciate it. I'm sure Mayor and Administrator – you take any calls from area businesses, as you indicated in the <u>Our Town</u> article, about the bridge.

in Jackson Township. The current payroll of their business is approximately \$180,000.00, with an additional approximate payroll of \$50,000.00 for new and part-time employees. When a tax abatement is brought forward, it is fair to the CRA. It is thoroughly reviewed by the CRA Committee before brought to Council. Mr. Wise: A number of construction projects going on - Bonnett Street Waterline, we just started. They started digging, I think, on Thursday. I don't think they worked on Friday, but they were up there today digging in the waterline on Lehigh and Watkins, and then they're working their way towards Bonnett. With regard to Dogwood Pool, there was some construction up there on Dogwood Street. They had to run a line to the sanitary sewer, and that's progressing. They started digging this morning, and that's going pretty well. Cordelia and Summit waterlines will begin fairly soon. I missed the pre-construction meeting on Cordelia, so I don't know exactly the date that they're going to start on that, but those will be starting soon. Marquardt, which has been going on for quite some time, will be finished, I'm told, on Thursday or Friday. They're actually milling the street. They milled the street today, and they'll be laying asphalt tomorrow and maybe Wednesday. And, then, it takes a little - just short of a day before anyone can drive on it. So, hopefully by Thursday, it'll be open for traffic completely. Main Street is progressing. We've had a lot of complaints from the people on Knoll and Northfield and Greenway, and we're trying to alleviate that the best possible way. There's also been some complaints from businesses with regard to that not being marked as a detour. So, it kind of goes both ways - the residents don't want it to be a detour, and the businesses south of there want it to be a detour. But there is significant traffic on those streets. We've put up a lot of signs, and, I think, the four-way stop at Northfield and Knoll is working out pretty well. I haven't heard any complaints about that. They have taken down the traffic lights at the intersection of South Main and Everhard. They did that this morning. There are now stop signs – well, there always have been stop signs down there since the construction began. But there are stop signs with flashing lights on them. That, I think, is going pretty well. I spoke with one afternoon shift officer today, and he's not aware of - and I shouldn't say it - he's not aware of any accidents at that location to date right at - on South Main and Everhard. It seems to be going fairly well - that traffic through there. And, I think that's all I have. Thank you.

Mr. Foltz: Okay, thank you. Mayor.

Mayor Held: Yes, I'd like to invite the Council members next Monday – we're going to have a tour of the Water Treatment Plant at 5:30, and this will give you an opportunity to see our new upgraded and expanded Water Treatment Plant. I thought that members that might be interested in touring the plant – getting a little better idea as to what we have down there at the City, which is a fantastic facility. They've done a really nice job down there, and, so, we'll schedule that for this Friday at 5:30.

Mr. Foltz: Monday.

Mayor Held: Or, I'm sorry. This Monday at 5:30, and so those that can attend, I'd love to have you down there. And, members of the press, if you'd be interested in touring also, that would be a good time to do that. And, then, I'd like to thank members of Council – those that attended the State of the City. It was nice to see you there, and I think it went really well. We'd also like to thank all the department heads – they put a tremendous amount of time – you really can't appreciate how much time was put into that presentation just gathering all the information from each department. Eric Bowles did a real nice job putting the presentation together on the Power Point and, also, Julie, for gathering all the financial data. I know there was a lot that we asked of you to get together, and that was nice. And, E.J., you were there until, I think, 11:30 the night before putting that together. So, I appreciate everybody's help and support. And that's all

Mr. Foltz: Okay. Member Lane.

Mr. Lane: I just want to thank the administration for their help on that Knoll, Greenway and Northfield situation. It's not fixed by any means. It seems like every day that goes by, more people find the cutoff – or the cut-through, I should say. The biggest problem that I've had – I've been over there several times, and I was over there on Saturday for

a while, and I'll sit around and watch, and the car traffic seems to be proceeding. Although, you've indicated that the amount is much higher, and you've got a lot of pedestrians through there and no sidewalks. So, it's a, excuse me, it's a dangerous situation, but the car traffic seems to be working. What's starting to happen now is delivery trucks — there were a couple of dump trucks through there today that had nothing to do with the Main Street project. There was even a car carrier. I don't know how it got in there, but it was coming down Knoll, and I don't know how it turned, how it got there, but it was there; and this was early in the process last week. So, I don't know if, in addition to everything else we're doing, if there's a way to post "No Trucks" or at least consider that as a possibility, that might help us a little bit along the way. But I do appreciate your efforts, and I think everybody understands that we're all gonna to have to live with it. But whatever we can do to help it along as it progresses, I think it would be appreciated. And hearing that it might be 12 days ahead of schedule is welcome news, as long as that keeps going that direction as opposed to slowing down. So —

Mr. Foltz: Thank you.

Mr. Lane: And I didn't realize Mr. Benekos wouldn't be here tonight. Will he be back in the office tomorrow?

Mr. Wise: Yes.

Mr. Lane: Okay. I've got a couple of project questions for him. So, thank you.

Mr. Foltz: Member Snyder.

Mr. Snyder: If I go to the Water Treatment, I get an extension on my taxes, because I won't be here in time to file them?

Mr. Foltz: He's still got til midnight. Right?

Mr. Snyder: Oh, well, then I'm all right, then. A couple things. I'm sympathetic to that, but we're reaching a point where we can't choke all the traffic off. That is a public right-of-way. You start stopping traffic – as you – first of all, you have too many signs. It's so damn convoluted, anybody who could drive a car could – there's too many signs all over – local this; stop; road closed. There has to be something drawn up where there's signs at Everhard and so forth, so that the natural flow will take the detour.

Mr. Lane: I think the one at 44th ended up missing for a while.

Mr. Snyder: Well, it's because of the O.D.O.T. You can't put that – it's not a break-away sign. And we are beginning to choke the merchants on both ends of the street. And, I mean, there are too many signs, because it's very difficult – I see people turn around right in the middle of the street now. And that's what's going to happen, because it's not a direct – if there's a sign at Everhard telling them to follow Easthill and around, they'll follow that, because they're looking for Fishers or whatever they're looking for, and northwardly, people do everything by habit. They don't do – they don't – you know, they just know that's the way they normally went. But that would be my only question to that. And, then, the other thing I need some guidance here. And I say this, also, to Director Wise. I notice that there's been sent a moral claim for my committee for next consideration. However, I have just received communications from Members DeOrio, Repace and Hines relative to a moral claim. And I just want to know if I can postpone that moral claim consideration until I can bring in tandem both that consideration and that claim, which would be two (2) weeks. Is there a problem on that? Is time of the essence on that?

Mr. Wise: No. It's entirely up to you.

Mr. Snyder: Well, I think to be fair to both the Council and to the person that's submitted his moral claim that there be some concrete process that we can continue to follow. And I know that's not the normal channel, but I was advised today that that was sent over here, so I'm asking for leave – if I could leave that for another couple of weeks. And I will consider – I appreciate your allowing me time to look at that and will share it with my committee. Although, you were the architect of it, so I won't have to share with you.

Mr. Foltz: Right.
