Recognition of Visitors

Mr. Foltz: Please, anyone who would like to speak before Council, step up to the podium, state your name and address.

Mrs. Shemenski: Hi, my name's Patricia Shemenski; I live at 204 Sutton Avenue NE, have been there for 36 years. I have some handouts for you folks. First of all, about 10, 12 days ago I left a – pass them over here ... inaudible... I left a letter for the Council of Whole here with the Council Office and I just wonder if anybody read that? It had to do with wild animal trapping. I mailed a letter to Ms. Magel and the Mayor got a copy and the Director of Administration. And sad to say, I did not hear from any council person. I'm really upset about that. Don't look at me like that, you didn't call me. Not one of you. Not even Ms. Magel, my ward council person...

Mrs. Magel: I was at your house.

Mrs. Shemenski: called me.

Mrs. Magel: You weren't home.

Mrs. Shemenski: You were at my house?

Mrs. Magel: I - my husband and I went to your home.

Mrs. Shemenski: Well...

Mrs. Magel: Rang the doorbell, but you weren't home.

Mrs. Shemenski: Well, apparently I wasn't there. The phone still works. Anyway, I'm here to request that the City consider, once again, hiring a trapper to get rid of nuisance animals in the City. I know that's a point of contention for some people because that would involve trapping on private property, but I believe that the City is partly responsible for these animals coming into the City because you've allowed so much development without considering where the animals are going. You're talking about all the development out there at Walsh, and you know, putting in the walking trails. There's animals living out there. Where do they go? They're coming to my yard; skunks, raccoons, opossums, now a groundhog. It's not just your little bunny rabbits and the squirrels, it's these other animals that are coming. And they're living under neighbor sheds. That's another thing I'd like to have as...as for you guys to consider an ordinance when somebody wants to put in a storage shed, when they go to the permits office and they say "we want to put a storage shed in", I think you should require that they put in some type of permanent foundation so that animals cannot burrow under that because once a groundhog or something burrows under that the skunks move in with them, the opossums, they don't care who's living in there. They all go in and live together. And I have not seen a groundhog in my yard for at least 20 years, but there's a groundhog now. There is a groundhog. And just today, people three houses down, they're new to the neighborhood, they put in a store, they had somebody put in a big, huge storage shed and I think it's right on the property line. I don't think they even, maybe not even got a permit for it, or found out how close to the property line it's supposed to go. But it's right smack at the back of that yard. And...we're just - have animals. I have there a list, I called six different trappers to see what they charge. And we, I have hired somebody, since you guys won't pay for it. When I called the City, I was told that you no longer pay for it so I have hired somebody. In fact, this fellow works for the City, works for the street department. And he's been coming and...you know, that - some of those high prices are outrageous, what they're charging, but, but... I think you should really consider doing something about an ordinance when somebody puts a storage shed in. These things can be retro fitted. One of the trappers I talked to said that you know, even if these, these things you just put right down on the ground, a lot of them. He said that once somebody goes in there and pulls the animals out they can - they can put some kind of wire, put something around there to keep - but with all this development out here at the Sanctuary, and all these places, these animals, you know, where do they go? And if you guys don't want to pay for it then, you know, let's have some type of compromise, share the cost do something, but...by the way, you'll see that the last thing I have there on my little handout. I printed this out from your website today, the North Canton website. It says you guys are paying. It says you guys are paying. And if you're not going to, then get rid of this right now. Don't keep telling me when I call up "we do not pay for it" because your website stills says that you do. And there is a need because I talked to the fellow who was most recently under contract and he said he made hundreds of service calls to North Canton, included one from the North Canton Police Department who called him and said, you know, we need help getting a critter out and he said "I'm not working for you guys anymore". But yet every time I called Administration they oh, you know, call this fellow, he's the, no he's not. But this says that you are. So I think you know, please, think about this. I know, you know, my tax payer money goes to a lot of things I don't use. Or a lot of things I don't want. I don't care

about streetscape. I don't care about that. I don't use the parks. I don't use the swimming pool. But I do get wild nuisance animals in my yard. Thank you.

Mr. Foltz: Appreciate your comments ma'am, I know we did have a line item this year on that and...we'll maybe have some further discussions to Administration as far as what is no longer being provided as a service, and...hopefully someone will get back to you about that.

Mrs. Shemenski: But I mean, like I say, what – what – what angers me, what frustrates me, what disappoints me, is that not one of you people bothered to call me. I've been here 36 years, I've hardly asked for anything from this City, nobody called. You know, you're responsible to your constituents and – and everybody in here whether they voted for you or not. But nobody called.

Mr. Foltz: Okay, would someone else like to address Council this evening?

Mr. Uhlman: Good evening. My name is Paul Uhlman, my wife Kathy and I live at 1144 Rosewood Street S.E., North Canton. And at the beginning I would like to say we've been a resident of North Canton for approximately six years, I've never lived in a finer community. We're extremely happy. However, there's always a however. However...in the time we lived here, we talked with my other neighbors, we have a problem with Eastwoods allotment. We have deteriorating streets there. I do realize that Council has a lot on their plate as far as money goes, but I think we're starting to look at a safety issue. We - Doug - our councilman Doug, we had a meeting with him, and we talked about this, we knew that streets improvements are like number three on the priority list for allocation of money. I took it upon myself to have a petition signed by our fellow neighbors and some of the people have copies of that, I'd like to submit the original petition tonight and for consideration of Council. ... Some of the streets are very - my street...Rosewood is very deteriorating. I've fallen, some other people, I knew of some children who have fell - fell on their bikes. We're talking about a safety issue...We're not Maple Street, we're not a main thoroughfare, but I think some consideration, some of our neighbors say that we've been, our City Council's been talking about doing improvements there for in excess of 10 to 12 years. We would like to have some consideration for this. At this time, I'm going to have my wife Kathy read, actually just a little paragraph the petition says, with your permission.

Mr. Foltz: Yes.

Mr. Uhlman: Kathy?

Mr. Foltz: Hi.

Mrs. Uhlman: Good evening. This is concerning the Eastwoods Allotment Street Improvement petition. "We, the undersigned, being homeowners in Eastwoods Allotment, in the City of North Canton, State of Ohio, hereby petition the City Council to evaluate and construct new streets in our allotment. Our main concern is for the safety and well being of our children and loved ones. However, we know that these are economically difficult times, but we feel that we have been more than tolerant with the condition of our deteriorating streets. Thanking you in advance for your consideration in this matter."

Mr. Uhlman: Thank you. At this time I'll give this to Doug, the original, and again, you know, we're not a bunch of rebel rousers and we're not going to throw tomatoes at nobody. But we just want consideration, we feel this is important, this represents in excess of 95% of the whole allotment. There's over 70 names here. So we would like to have consideration for this in the future.

Mr. Foltz: Okay.

Mr. Uhlman: Any questions or....

Mr. Lane: I would like to interject if I could...

Mr. Foltz: Sure.

Mr. Lane: and I don't ...

Mr. Uhlman: Yes

Mr. Lane: Just to let you know, and maybe I could check with Mr. Benekos, check the timeline on this, as you know, one of those streets was scheduled to be done this last year....

Mr. Uhlman: Correct.

Mr. Lane: It got lost in the budget wars...

Mr. Uhlman: Yes.

Mr. Lane: and at the same time, in the midst of all that discussion, Mr. Benekos had a major problem with the underlayment underneath those streets out there. So we appropriated \$25,000 for this year to drill all of those streets to find out what's under them...

Mr. Uhlman: Okay.

Mr. Lane: to determine the best route to go, which streets ...should come first, you know, what that surface should look like...

Mr. Uhlman: Okay.

Mr. Lane: so we don't put quarter million dollars worth of concrete down and find out it's gone in 5 years.

Mr. Uhlman: Great.

Mr. Lane: So I - I'd like to turn it over real quickly to Jim to see where we're at in that process, just so you know that we haven't forgotten you.

Mr. Uhlman: Wonderful, that's – that's – that's all we asked.

Mr. Benekos: Sure. Within the next month you should probably see a - a rig out there boring, taking some boring samples, determine what the - the soil conditions are out there. One of the questions I did have for Council, or for the residents also, is you know, we can rebuild those streets with concrete, which will cost more and you can do less streets at a time, or we could rebuild them with asphalt and - and...we'll get prices for both of those...When the allotment was put in and - and the price of the lots were put together, they were put together based on - on concrete.

Mr. Uhlman: Correct.

Mr. Benekos: I think in the past the...inclination of Council was to replace concrete with concrete. But...you know, at a lower price tag...l don't know how the budget's going to be next year but, you know, when we look at projects I'll present that to Council both and - and at that time probably Mr. Lane will probably speak with the residents to see if - if there would be a willingness to go with asphalt at that time.

Mr. Uhlman: Good, good. Again all we're asking for is consideration in this matter. I think we all agree that the streets are deteriorating. The general consensus of my fellow neighbors, who I petitioned, they do want concrete, however we got to be realistic.

Mr. Benekos: Sure.

Mr. Uhlman: You know, if it's feasible we would like to have concrete put back but I think safety's first.

Mr. Benekos: Okay.

Mr. Uhlman: So thank you very much, gentlemen and I'll give this to Doug.

Mr. Lane: Thank you and I will let you know once I hear from Jim.

Mr. Uhlman: I appreciate that, thank you.

Mr. Lane: Thank you.

Mr. Benekos: Thank you.

Mr. Foltz: Okay, thank you sir. Anyone else like to address Council this evening?

Mr. Beinlich: Good evening all, I'm Paul Beinlich Director at the North Canton Y.M.C.A. 200 South Main Street. I came here tonight on behalf of the Board, staff, and members of the Y.M.C.A. to just thank the Administration and City Council for their cooperation and help this summer for our pool emergency, so to speak, that we had. We really do appreciate it, and everybody does and...at this point in time we're just about – the pool is just about finished, and I think as far as...our...collaboration, so to speak, and your help for us this summer, we're in pretty good shape. I think from what I can tell, everyone had a good...good experience and hopefully you heard that, Kim Cooksey and Matt Johnson were of - extremely helpful and did a lot for us during the summer and we appreciate that and I just want to take this opportunity to

thank you all for all that help. I think it was good community program and...hopefully there can be some things we can do in the future.

Mrs. Magel: Paul, when do you think you'll be re-opening?

Mr. Beinlich: We should be re-opening, I hate to say exact dates...

Mrs. Magel: Well...

Mr. Beinlich: but I hope it will be the week after...Labor Day weekend, and maybe even, if we're lucky, cross our fingers, Labor Day weekend, but...

Mrs. Magel: Wow, that's great.

Mr. Beinlich: But it's – it' real good, there's water in the pool, and we're trying to balance it, we got clean up work to do and a few finishing touches that have to be done but...okay.

Mr. Foltz: Appreciate that. Yeah, to echo your same statements...to one of our rec board meetings...Kim Cooksey did say what a smooth transition that was...a nice collaborative effort between the Y and Dogwood Pool, so...

Mr. Beinlich: Yep. Thank you very much.

Mr. Foltz: Glad it worked out for all parties involved.

Mr. Beinlich: Okay.

Mayor Held: Thanks Paul.

Mr. Foltz: You're welcome. Anyone else like to address Council this evening?

Mrs. Haines: Good evening. My name is Helen Haines. I live on Orchard and...recently you redid our streets and...put curbs and did our, I don't know the technical term I call them devil strips, and...as it as, when they came up...they are nothing but weeds and they look terrible. And all of the neighbors are very upset, I gave Kathy a letter with signatures, she took pictures and she said she understood because it is – it's an eyesore. And on the edge of our lawns where we've had our lawns treated where they put seed, it's...the weeds are coming up into our yards, and it's a – it's just a real problem. If you pulled all the weeds you wouldn't have any grass. It's just terrible. And I know they always talk about beautifying North Canton, well it - it doesn't look very pretty. And it - it's just – it's not something we should have to deal with, it...since they went to bother to do this, I think they should have done it right, the first time. As my father used to, if you're not going to do it right the first time, don't do it. So that was my complaint, and Kathy, I said, has the pictures and the letter that I sent, and we would appreciate if they would be redone.

Mrs. Magel: Yes, I – I guess I would like to concur and...read the letter. "Dear Council Members: We the neighbors of the above residential - and that would be 9th, Orchard, Overland - were very pleased with the repairs and improvements to our curbs, streets and sidewalks. The finishing touches left a lot to be desired regarding the work of the damaged yards and – and devil strips. The fill around these areas was not a high grade of topsoil but was a mixture of stone and weed mix...It seems as those this portion of the job was done in a rushed manner. Several residents called about the condition of their yards and the contractor was brought back to re-till and reseedmost of - most, if not all of the areas have been worked on twice, the City's contractors are weed filled. It's hard to believe that this type of work was done on your own properties that it would not have been removed and replaced by now. We would like to have the City re-inspect the properties in an effort to correct the problem for the third time. I went...to her residence, as I did to the other...lady's residence, and...I - I see her position. They have very nice grass in their yards. And then there was the sidewalk and then there's a devil strip and it's weeds, didn't you have this problem?"

Mr. Lane: Yeah, its – its - I think Mr. Benekos will concur with this, that almost every project has, it seems like this happens about six months after the end of the project. That for some reason it's either, I don't know, not high quality seed or something, but I've had it, it happened on Pershing...

Mr. Lane: it happened over on Knoll and a couple of my other ones. So, I don't know ...

Mrs. Magel: And I have it here now. So I would, as I supported you, Doug, I – I would appreciate if Doug would, if Council would support me and please have this looked at. ...It is signed by many residents in the area and I guess, Gail, I can give you a copy and...

Mr. Snyder: Mr. Benekos, I think, and I don't mean to put more sand on someone's face but, you look at Bonnett, it has the same problem. We talked about this, I mean for a few thousand dollars you, we would require the contractor, in the bid, to use other than highway seed. That grass they put is about 90% crabgrass. With the condition of the atmosphere of this past spring, when you're growing crabgrass in the middle of July there's a problem because you can't use pre-emergent till next spring and there's nothing those people can do. But it should be required when you are doing a — like Bonnett — a \$900,000 project, and we're using \$200 worth of highway seed, that you should be feeding cattle with what's growing up out of there, that — that's really an insult to the integrity of not only the fine job they did, but to the - to the citizens of the city. And I think it should be required that the contract read "residential blue grass seed". And it would...because by the time we get back to it next spring, the actual warranty period is exhausted and it is...I don't have to tell you, and I - and I know, that contractor's very meticulous but again, he's only following the — the marching ...

Mrs. Magel: Specs.

Mr. Snyder: orders that he gets from the city. If we could do that, I think we could eliminate 90% of our problems. And it shouldn't be that, but again it's – it's a seasonal thing, we normally don't have extremely hot days without rain that you can germinate crabgrass in the middle of July. That's usually, that's a very unusual situation. I do know that's a problem.

Mrs. Magel: Well, you know, it's hanging over the curbs, and it's just not a — it's not attractive and — and she did, she thanked the you know, for the work that was done. But, so hopefully, you know, let's let...

Mr. Foltz: Let's – let's have the administration...

Mrs. Magel: do this for the neighborhood.

Mr. Foltz: look into that, see if there's any contingencies left. I agree with all the comments made by Council, everyone takes care of their yards for the most part here in North Canton. Its tough when you see a curb line, lawn, excuse me, that just doesn't meet the grade of your existing front lawns or side lawns so...

Mrs. Magel: And - and - and that's the case here.

Mr. Foltz: maybe in the future, for our engineer, maybe, if they have to put a quick grass down because they are running late on the project, that they have to come back with a contingency that spring, and replant that so there's better growing environment for that seed. Let's build that into the contracts. You're absolutely right, spend \$900,000 and have a substandard curb lawn is just not acceptable to the City of North Canton. So let's have Administration look at that and we'll see what we can do for you.

Mrs. Haines: Thank you very...

Mr. Foltz: We appreciate your comments here tonight.

Mrs. Haines: Thank you very much.

Mr. Foltz: Okay, thank you. Anyone else like to address Council this evening?

I have to keep this consistent with other meetings. So I thank you for your comments earlier, but we'll let Administration's answers address it with this specific Council question, so...thank you. Anything else? Mayor?

Mayor Held: I can — I can comment on this. It really, what's happened, the original intent of the - the appropriation of the funding for the animals were...as I understand it, was for animals that were on...public property, on the city's property. And then...somehow along with period of time, the program evolved to where the city began hiring contractors to trap on — on ... private property. We have had a number of residents that have called and expressed their concerns that the City is...spending.... taxpayer dollars to...trap the animals. And then the next question is, is...which animal is a nuisance? You know, is it an animal that is a rabid animal, and that we have to go out there and address it, ... which we've done that from time to time at the police department. Or is it just any animal that is on the property that can be trapped, or is it an animal that is...burrowed underneath the...the home or the...let's say the shed. And so, really, I think, probably the best thing that we can do is probably have Council address that...in the form of an Ordinance...so that we can clarify really what the City's position's going to be on that.

Mr. Snyder: You know, I think what happened Mayor, no disrespect, it took so long to get a green space ordinance that we ran out of land that was open public space and it all became private land. Maybe that's what happened.

Unidentified: You got that right

Mr. Foltz: It - it still doesn't work.. inaudible

Mrs. Magel: That was a good line.

Mr. Wise: I – I spoke with...Mr. White today...in my office, he's, I don't know if he's in charge of the Association but he's ...

that the trails in the Sanctuary were going to be given to Stark Parks. Well then they're not the City property at all. I don't even know where that's at, so...that didn't answer your entire question, but it just shows you how this is being...

Mrs. Hines: I'm - I'm just saying that they advertise the Sanctuary's...

Mr. Foltz: it's being piecemealed throughout the county with different – different groups and organizations who contribute to the overall trail design, who is specifically is in charge of that, it really falls on those allotments.

Mr. Snyder: It runs opposite of Woodside. 5th Street runs east and west, Woodside runs north and south.

Mrs. Magel: Right. He - they're cutting through 5th Street, between Woodside and what would be imaginary 5th Street. Between Woodside and...Wise.

Mr. DeOrio: You see, we got this and this, it's down there...inaudible...

Mr. Benekos: Right, 5th, the sewer on Wise does not extend up that far.

Mr. DeOrio: just...inaudible...street there....

Mrs. Magel: Okay, so, well, I'll talk to you later, but for sure, we're not going to put a alley, a street, a ...

Mr. Benekos: I'm not.

Mrs. Magel: path.

Mr. Benekos: No, I'll they're asking is to extend the...sanitary sewer.

Mrs. Magel: At this point in time. But there's not going to be like two houses on this side and two houses on this side and a 5^{th} Street made, or a 5^{th} alley made.

Mr. Benekos: It's not my...

Mr. Foltz: Those aren't your intentions at this time?

Mr. Benekos: not mine.

Mr. Foltz: Okay.

Mrs. Magel: Yeah, but is it the developers?

Mr. Benekos: No, I don't believe so.

Mrs. Magel: Has he gone to planning yet?

Mr. Benekos: He didn't even want to put in the sewer.

Mr. Snyder: He has to by law.

Mr. Benekos: Yeah, he has to put in the sewer, he wants to build a duplex on - on that corner.

Mrs. Magel: I - I thought it was a duplex, I mean, what else can I conclude?

Mr. Benekos: But, I'm sure he doesn't want to go through the, any more expense than he has to, and there's no need to build a street, he'd just be losing...

Mrs. Magel: Okay, unless, you know, you could take the lots from here, put a street here, and put two lots, make four lots out of two.

Mr. Benekos: Yeah, right, yeah, he'd have to go to planning commission for that, and he...

Mrs. Magel: And you don't feel there's any intentions for that.

Mr. Benekos: No. No.
