Recognition of Visitors

Mr. Foltz: At this time, we'll open up to public speaks. Any recognition of visitors here? Please step to the podium and state your name and address.

Mrs. Goldthorpe: I'm Debbie Goldthorpe. I reside at 287 Orion Road, NE in North Canton. I'm speaking tonight as a citizen of North Canton, primarily, and secondarily, as Chairman of the Chamber of Commerce. The City and residents of North Canton have had the security of knowing The Hoover Company has been here for us since it was founded. It's been the anchor - the source of support in all ways and the ultimate good citizen of North Canton. Now we are being faced with circumstances never before experienced by our City. There is negative talk and discussion about the loss of jobs, the resulting loss of income and tax base, the future of the appearance of the center of our town. The list of worries is real and extensive. Because of the current focus on the negative, I want to remind you of the good things which North Canton has to offer. First, we have an actual town with a definable center - an identifiable crossroads that says this is the middle of the City of North Canton. We have excellent schools. People have moved to North Canton for years so that their children could attend our schools. We have businesses which have been here for many years - successful, well-run businesses whose owners believe in North Canton. We have a Chamber of Commerce which has over 400 member businesses. We have a community building YMCA originally provided by Boss Hoover and which has enriched the lives of youth, adults, families and seniors for decades. This YMCA currently serves 15,000 members - all on the square of our City. We have an active faith community. Many churches have been here for years serving generations of families. We have an ever-growing university which has actively initiated progressive conversations about collaborative possibilities and is enthusiastically sharing its resources with the community. We have affordable neighborhoods - many within walking distance of the center of town. We have excellent safety forces. We have a library rated the best in the country for its size. We have cultural activities, both in our community with the North Canton Playhouse and The Little Art Gallery, and easily accessible offerings in larger cities nearby. We have recreational opportunities provided by the City - beautiful parks, pools, walking paths. We are a place that people have always wanted to live. As Council members and our City administration, you have effectively been charged with doing your best to assure that that continues. It is important that you discern the difference between the vitally important and the less important issues and that your efforts stay focused on those issues that would determine the future of North Canton. There is nothing more important than the issue of economic development for this City - not potholes, not streetscapes, not windows put indoors, not power plays. We have an Economic Development Director, a CIC (Community Improvement Corporation) and a plan to make a master plan. A master plan is years late in being created. Our reliance on The Hoover Company to care for our City has backfired, now, and resulted in an unprecedented sense of urgency. This situation requires each of you to look beyond today and be committed to a broader and deeper vision than our City government has ever demonstrated in the past. The most immediate and crucial issue that will positively impact economic development is the passage of the upcoming school operating levy. The passage of this levy is absolutely vital to the sustenance and growth of North Canton. The outcome of this election will tell the world, Ohio, surrounding communities, potential businesses and families whether we really value our youth and families and are willing to invest in their future. I urge this administration and individual members of City Council to actively and unanimously back the passage of the operating levy and then to work to assure its success. You, as well as the citizens of this community, must be open to change and work with it. We cannot go back to the easy days of being cared for. Let's be willing to create an environment that welcomes new industries and technology. North Canton could be the birthplace of the next Google, but not without proactive steps that pursue creative opportunities. I believe that the synchronized program for business retention and expansion is a step in the right direction. The Chamber's Economic Development Committee and its volunteers will team with Mr. Bowles to obtain important information about what our businesses need to stay here. Each of you in the entire community should be very, very concerned about the empty spaces along Main Street. I urge Council to consider, again, the issue of a community sign. Aside from Our Town, the monthly newspaper that Jim Dansizen prints, we have no way to communicate with our citizens and others what is happening here. There is

> no way to promote that we are an active community. Communication can not be overrated. Please act on this issue. The sign ordinance. This sign ordinance, as it now stands, has a potential to drive businesses out of North Canton by declaring many signs out of compliance. The Chamber has done some work on this since Council last addressed it. The issue needs to be addressed immediately before another negative message is sent to our businesses. There's never been a greater sense of urgency and need for broad vision than now. Yes, we need a plan. We've needed a plan for years. Agreement on what the plan will be will require compromise, hard work and some hard decisions. Making the plan come to reality will also require compromise, hard work and hard decisions. My question is, are you up to it? There could be risk involved in thinking out of the proverbial box out of what we've known for years. There could be risk in working toward creative solutions to our issues. But consider the risk of continuing to do what has always been done. North Canton could find itself as the city that used to be a great place to live. So, now, before it is too late, I urge you to take decisive, proactive and progressive steps to assure that North Canton grows with vision and in depth. I urge you to make decisions that are designed to create opportunities which attract young adults and families to live and work in a vibrant North Canton. I challenge you to work together sincerely, unselfishly and cooperatively in efforts focused on specific goals and purpose. These efforts must be based on an established vision of possibilities and opportunities. And the vision must be bigger than the sewer and more broad based than your ward. You are the ones who are determining the future of North Canton. You're making the decisions and studying the priorities. You have the opportunity now to recreate North Canton into a city where young adults and young families provide an educated workforce to meet the needs of new and exciting industries. Thank you.

Mr. Foltz: Thank you for your comments. Anyone else like to address Council tonight?

Mr. Osborne: My name is Chuck Osborne. 307 Fairview Street, North Canton, Ohio. I don't have prepared comments tonight. I'll keep it short, Mr. DeOrio. I do thank you for your public acknowledgment and your kind words. I'm here to speak on Ordinance No. 20-06 - the third reading of the withdrawal from Plain Township. I wanted to speak several weeks ago, but we failed to have concluding remarks from the public the last several meetings. And I'm also prompted to speak today regarding Mr. Michael Hanke's column today. He seems to espouse some kind of voter possibilities of how North Canton voters can structure and control Plain Township. Office holders, I certainly do not agree with that. I think it's difficult enough for voters to keep abreast of their own local politics much less trying to control what goes on in their adjoining communities with regard to their public officials. So, I highly encourage you to, to move ahead and pass on its third reading this ordinance to withdraw from Plain Township. I would like to confide with you something I learned three (3) years ago when I espoused this myself, and I got this straight from the Township Administrator at the time. Every year, the money that we would give to Plain Township - you know what they did with that money? They put that money in their anti-annexation fund. So, we have been actually funding efforts to proceed with annexations against ourselves. I don't know how much they - that fund has accumulated, but as Mr. DeOrio and, I believe, Mr. Repace, has pointed out, just in the last three years, it's close to 80 grand. So, we've been, basically, pulling the rug out from under ourselves for our efforts to survive and grow in this community. So, I applaud you and, again, encourage you to proceed with this. And I also would like to second what Ms. Goldthorpe had said about the North Canton City Schools. Academia is, is going to be the mainstay of this community in years ahead - a strong school system - not only at the grade school / high school arena, but also at the college level, with Walsh and its growth. So, I certainly want to second her comments about the strong school systems and supporting the levy. Thank you very much.

Mr. Wise: All right. So, we spent a little bit more than what I'm about to say. But about \$42,000.00 this year – so, a little less than \$60,000.00 less than we had spent last year at this time. By the end of the year, I think we had purchased \$240,000.00 worth of salt last year. Now, some of that is what we were using at the beginning of January, but the total amount used so far other than tonight was about \$42,000.00.

Mr. Foltz: That was my question. Well, I know we had emergency legislation to fill up our salt domes last December. So, that's sort of a seasonal cost you're giving us? You say this year – you mean our winter season?

Mrs. Herr: No, that's --

Mr. Wise: No. I'm sorry. January through February 27th; right. Last year – those two months we spent about – a little over \$100,000.00. And this two months this year we've spent about \$42,000.00 plus tonight.

Mr. Foltz: That's very good news. Thank you. Mayor?

Mayor Held: Yes. I'd like to announce that on March 13th we will have our first Economic Development Task Force meeting. And there will probably be anywhere between 15 and 20 members. And what the Committee is going to be charged - or the Task Force is going to be charged with – the responsibility of developing an economic development plan and also considering a master plan for the City. An economic development plan, as I had it explained to me, usually takes between six months - six to eight months. A master plan is a lot more extensive and really includes - a master plan would include an economic development plan. But the first priority that the Task Force will be charged with is establishing an economic development plan. I have spoken with Council members about the Task Force, particularly Mr. Repace, because he is the Chairman of Economic Development, and I asked if he had any interest in serving on the Committee. And he had referred me to Mr. Lane, because he has - Mr. Repace is also serving on the Chamber's Economic Development Committee, and so now Mr. Lane is going to be representing the City - or City Council, rather, on the Task Force. And, really what the Committee is going to do is - this isn't going to be a substitute, or it's not going to replace the work that was done by Imagine North Canton or the work that the Chamber of Commerce has been working on from an economic development standpoint, nor the TAP (Talk About Potential) Committee. Really, what this is going to do is act as a hub for all of the work that all the other committees and community groups have been working on. We want to have one (1) task force that is going to be charged with putting together the City's economic development plan and, of course, including all that input from all the other community organizations. And as things progress, we'll make sure to keep all members of Council up to speed. And, certainly, if Council members would like to come and observe those meetings, there's not a problem with that either. And, so, that will be March 13th at 5:30 p.m. is the first meeting. That's a Monday.

Mr. Foltz: Anything else, Member Hines?

Mrs. Hines: No, that's it. Mr. Foltz: Member Repace.

Mr. Repace: I do have something. On February 13, 2006, North Canton resident Chuck Osborne approached City Council with comments made, and I quote "there have been certain actions by this Council that are not in the best interest of the residents of North Canton." I believe every resident in North Canton, including Mr. Osborne, has the right to address City Council with their questions, comments, suggestions, concerns, constructive criticisms, criticisms or any other topics. I do feel, though, when someone wants to offer criticism or perceives things the way they choose about City Council, Council should have the right to respond. Although, everyone should be held accountable for what they say, including Council members. During these past two weeks, I have been disturbed over negative and inaccurate comments made by Mr. Osborne to City Council that I feel were unwarranted. I do not disagree with everything Mr. Osborne says, but I do disagree with what I feel was a vicious attack on City Council with the way he perceives some actions taken by City Council. Mr. Osborne suggested that this Council was trying to create anxiety for key City employees by appointing former Mayor Tom Rice to the CIC, including continually making comments of this City Council being a pro-Rice Council. Maybe it's time I remind Mr. Osborne and others that the election is over. The citizens of North Canton elected David Held as Mayor. There is not one person on this Council that has not had a desire to work together with Mayor David Held and his administration. The appointment of Mr. Rice to the CIC was made by six out of seven Council members due to Mr. Rice's knowledge of the operations of the CIC and the value we felt he could offer. There is absolutely no cloak and dagger means to this appointment, contrary to Mr. Osborne's perception. Mr. Osborne also mentioned that the new City Council made a decision to close the door to the Council office and in its place install a service window in an effort to close out the public. Once again, this is Mr. Osborne's perception, along with, again, his comments of this Council being a pro-Rice Council. The service window was installed to increase professionalism and safety to the office, along with giving the office staff some privacy in doing their job without someone hanging over top of them or rummaging through their papers on their desks. Citizens will still be serviced and, if necessary, will be invited in. For Mr. Rice's name to even be mentioned in this issue was ridiculous. Another one of Mr. Osborne's concerns was what he felt the anxiety that this Council has brought on our City government by delaying the appointments of two key officials for weeks with the Finance Director and Law Director. On this issue, I do not totally disagree with Mr. Osborne, but I do disagree with his perception, once again. With four (4) new Council members, I believe there should have been a time frame for everyone to work together and get acquainted. I personally recognized the professionalism and dedication in Finance Director Julie Herr the first time I met her and had the opportunity to work with her. I do understand, though, how there could be concerns on the time frame of her appointment. Since my being elected to City Council, I have had the opportunity to work very close with Law Director Paul Pusateri on various items. I have found Law Director Pusateri to be very professional, along with displaying a tremendous knowledge of the laws pertaining to city government and his promptness in returning phone calls and response to the subject matter. At this time, Law Director Pusateri has not been reappointed and has chosen to resign. It will be a very difficult process to replace Mr. Pusateri with the knowledge and experience he possesses with our City government. I do agree with Mr. Osborne that both these individuals hold the highest degree of competence and professionalism, along with their positions being vital to the day-to-day business of our City. I do understand Mr. Osborne's concern on these appointments. But what I am struggling with is, if Mr. Osborne really believed in these appointments, why, when he was on City Council, did he abstain his vote for the Law Director? As far as the process of interviewing a new Law Director, I have no personal comment without truly understanding the proper procedures. But my understanding is the reason for all the interviews is to give each applicant equal opportunity. I'm sure if the process was being handled in a different manner by not giving equal opportunity, someone would have a derogatory remark about that. In closing, Mr. Osborne failed to mention in his criticisms that this Council has balanced a cost saving budget without compromising all the fine benefits the citizens of North Canton have grown accustomed to. There was no mention of all the water, sewer and street projects that are in the process of getting underway that previous councils ignored. The three (3) new police cruisers, the new ladder truck for the Fire Department, the extension of waterlines to the airport area, North Canton forming its own township, the appropriation of funds for the parks and recreation, along with many other projects. It is very difficult to understand Mr. Osborne's negative perception and comments. But I will say, constructive criticisms and suggestions are always welcome to this Council, and this City Council commits to

We haven't had a lot of snowfall this year, so I don't think that's really – need to be addressed through our residents. But I'd rather have it that way than our trucks not getting down our City streets at all. And, once again, I know we are known – our reputation in government entities in this area – as the best at snow removal and snow plowing and salting for our traffic pattern. So, I'd rather error on the proactive side than a reactive if we have a major snow storm. So, those are my compliments to your crews and just to City employees overall for the last – at least my tenure here on Council. So –

Mayor Held: Mr. President, with that in mind, also, just to remind Council and the residents here – that we do have – when our trucks are out plowing, we do have an observer in the cab which, in most governments, when they have their salt trucks out, it's just the driver. But we do that because we do have – we are very conscious of the curbs and the double strips and, so, we try to keep that truck down the center of the street – not deviating from that – so we put a lot of work on that. That's all. Thank you.
