#### CALL TO ORDER

- 1. The meeting was called to order at 7:00 p.m. by President of Council Doug Foltz.
- 2. The opening prayer was delivered by Rev. Dick Scherpenisse, (retired) Presbyterian Pastor.

#### Consideration

Council Meeting: January 29, 2007

Mr. Foltz: Thank you. Ask Council to consider our Council Meeting minutes for January 29 2007.

Mr. DeOrio: Mr. President. I have a couple comments on that, if I may?

Mr. Foltz: Sure, Member DeOrio.

Mr. DeOrio: Go on the bottom of page 142...Mr. Snyder is...commenting and there's a – a word in here that's...I don't think is the one he used, and I'm hoping he'll – his – he'll have a strong recollection...it says here, this was...in response to the – I think the Fairways but it says "it only appreciates in value, you know, 'cause we have...philosophically we differ, you and agree, he differs, but – and it's one of those things, but I don't think the City and I would differ to Mr. Chairman DeOrio" and I think you meant to say defer.

Mr. Snyder: I did, sir.

Mr. DeOrio: Okay, and...so I'd like us, 'cause there's a big difference between differ and defer.

Mr. Snyder: Yeah there is.

Mr. DeOrio: and I didn't want us to be on the opposite...sides there, so I would hope that we would be able to make that correction. And then...course this was the night that we were passing our budget, and...when we had got to that section of the...meeting, we were in the process of doing the motion and...Chairman Foltz was recognizing me to speak on behalf of the ordinance and while I was doing that, there apparently was a conversation going on across the aisle that many of the, I certainly wasn't aware of, I don't know that anybody in Council was, and I would hope that you would have read your minutes prior to it, but for those that were in the audience and don't have privy to - to read this, I'm gonna just read it into the record now. Mayor Held says Jim, I don't have to sign the budget. Mr. Benekos says no, you don't. Mayor Held says ten days and it becomes effective, right? An unidentified says ten days, you have ten days to sign the legislation. Mr. Benekos says you might want to think about it. Unidentified voice says probably not a good idea. Mr. Benekos says this will make the papers. Mayor - Mayor Held says that's alright. Mr. Benekos says think hard. Barely a a few breathes later, we get a thank you...from the Mayor for all of our hard work on the budget, for Benekos, for Earle Wise, for Julie Herr, for the department heads, and for City Council. And it goes on to say that he's - it's nice to see that the budget has passed right now. Well it seems clear to me that - that from the get go, before the vote was even announced, before it even took place, Mayor had decided that he wasn't going to sign the budget, and that's okay...

Mayor Held: That's correct.

Mr. DeOrio: but we were waiting for...word on that, and of course nothing appeared in the paper until the Mayor initiated a – a call or spoke to Dottie McGrew at the Beacon Journal, which wrote an article on February 7<sup>th</sup> indicating that the Mayor wasn't sure whether he was going to sign it, not sign it, veto it, and then also on that date, you received in your packet a letter from the Mayor to the Council dated February 7<sup>th</sup>, on the day that the article appeared in the Beacon Journal in which he says that he's decided not to sign it. But, I want to make sure that everybody's aware of what I would feel are the inconsistencies in what has transpired there.

Mr. Foltz: Okay, with that, do I have a motion to approve the minutes as corrected and as noted?

Mrs. Magel: Well, I - I gotta get oriented here. You're reading into the record - we -

Mr. Lane: It's already on the record.

Mr. DeOrio: Yeah, 'cause when you come back and look at this, it's - when you read it, it looks like that we're all having a conversation back and forth with each other, and that was not the case. So I just wanted to make sure that everybody was aware of that.

Mrs. Magel: Okay, so the Mayor says Jim I don't have to sign it, no, I have ten days, oh, we're having a conversation within a conversation. I see. Ten days before it comes into effect. Ten days you have to sign the legislation. You may want to think about that. It's probably not a good idea. This will make the papers. That's alright. Think hard. Okay, now then you're jumping to the reports. I'd like to thank council members for their - for their hard work on the budget. It's nice to see that it passed right now. Okay. I'm oriented. So, he was actually against it, before he was for it, before he was undecided, before he was against it. Thank you.

Mayor Held: If I could add, it's pretty clear that...our recording system's working well here at in North Canton. As far as my position on the - on the budget, I think I've made it real clear what I objected to through the Administrator...as far as what I objected to through the budget. And I was reviewing the decision to decide whether or not to veto the budget, whether to sign the budget, or not sign the budget. And I did not make a determination at that time. And I was - all that is correct. The dialogue that - that is presented on the recorder in the minutes, that's a discussion that I had with Mr. Benekos. Wanted to clarify whether or not I was able to veto it or not, and...so that's all true. That's correct. And I did decide not to sign the budget, which would allow it to become law, and the reason I did that is because the - the budget process went past December: We submitted our budget November 17th. It was approved at the end of January. We had various department heads that were waiting for their funding. There are a number of items that I did not agree with in the budget, however, because of the time constraints, we passed it on an emergency basis, right at the end of January. Because of that, I didn't want to have to have Council come back, have another meeting, and then at the same time, we have departments that are depleted in their funds. So I decided not to sign it, and there are issues, particular issues like the Lipton Street issue and the Police Department, the cutting of the Police Department, which I had conveyed to City Council through...an attached memo, and - and I plan to resubmit those requests so that City Council can reconsider the cutting of the Police Department because I do not feel that it is appropriate. I would also ask that City Council reconsider funding the Lipton Street project because I don't feel it's appropriate not to fund the - the design or the construction of the storm sewer on that street. So those are two definite issues that I will be proposing for reconsideration, or for Council to

Mr. DeOrio: Well, you know...

Mayor Held: But thank you for pointing that out to me.

Mr. DeOrio: But you know by not signing the legislation, you made the department heads wait ten days more.

Mayor Held: Right.

#### 7. Recognition of Visitors

Mr. Foltz: As I made note at the committee meeting, we will have public recognition of visitors, but I will not tolerate members or citizens speaking out from the audience. We will have a professional meeting here. I pride myself on that with a positive image of North Canton. We can agree to disagree, but there are parameters of Robert's Rules of Order that we must abide by. I think we owe it - that to...to ourselves and to our residents that we all represent. So with that said, I will not hesitate to remove somebody here that doesn't abide by those simple rules of professionalism. With that, do I have anybody here that would like to address Council this evening?

Mr. Feiler: Chris Feller, 1291 Lipton. I'm sure everybody's aware of my name and my address by now. As everybody is aware, I'm here representing the residents of Lipton Avenue. We have been working with City Administration and Council on trying to get some road projects completed with on our road and some surrounding streets. I was told here two weeks ago that if we didn't see some sort of surveying work or initial study work being conducted by the end of February, we probably would not see any work commence on our road for again this year, make that about eleven years straight now. I would like to ask Council, number one, if any funds have been allocated on paper to this point, as to any design work being constructed on our road, as everybody's well - well aware, there's limited firms in the county that do this kind of work. We are now behind every major city and township in our county with regards to that matter. So my first question would be, have any funds been allocated to this? My second question or comment would be, I'm not sure if under the consideration of Council meeting minutes if that's the place to...address where newspaper articles are placed and repeat things that are the minute but - minutes, but I would certainly hope that if that kind of due diligence was taken in maintaining our minutes and correcting previous month's minutes, that the same due diligence was taken in evaluating funds for the Lipton Avenue project. I've talked to several gentlemen here within the room, that we're looking at various grants through Stark County Regional Planning. I guess, yeah, that's a long term solution, but being the triennial process that the Stark County Regional Planning works on, the earliest that we would see any spending plans submitted for grant money would be the fall of '08 with monies not being allocated 'til spring of '09. That now puts us at least two solid years downstream of this project. I just wanted to know if I could get Council's feedback on where we stand with this, what kind of due diligence has been paid to this project, and if anything has been put on paper with as far as planning or future work is concerned. Thank you.

Mr. Foltz: Okay, thank you sir. Now, if anyone would like to address that? The committees or Member Snyder, your ward.

Mr. Snyder: Thank you, I appreciate it Mr. President. Thank you, Mr. Feller. Pursuant to your request, I have talked to Chairman DeOrio who's the Chairman of Finance with...some of the ideas that were forwarded to me. I've had conversation with the Director of Finance, the Administrator, the Engineer, and Mr. DeOrio has, in fact a littler this evening, has assured me that I'll receive a phone call tomorrow, relative to what we can do and we're still hopefully, as I say, even if we got the money for the 25,000 approved next week...l don't know how soon we - hopefully by March when the snow leaves we can begin the staking. But...we have not forgot you, I assure you, you know that that's uppermost on mind. And I know that Nick and Amy are concerned about the rainy season. There are plans afoot to address that one specific house initially, no matter what happens. Contrary to some people's belief, they feel that I've heard told to me that the flooding is a one house issue, it's not. Every house on Lipton receives water, there is absolutely no storm drainage, no ditch. It is a problem, all of it fortunately doesn't seep into every home. But it is not a one basement problem. It carries from the far southern end to the far northern end, and is relative to Director Bowles which I'm bullied by his willingness to help us with county grant money. That's for the whole area. We have to address Lipton separately right at this present time. It is a priority, it's my priority, and we have not forgot you and I appreciate you coming up and continue to speak. But every member of Council, we find that money, we'll do that project and I think they'll ...inaudible...up.

Mr. Foltz: Thank you Member Snyder.

Mr. Snyder: Thank you.

Mr. Foltz: Anyone else like to address Council this evening?

Mr. Davies: I'm Jeff Davies, I live at 1121 Southwoods Lane. In regards to the \$25,000 for the study, I suggest you take the money that was earmarked for the community sign and use that. I sit on the Economic Development Council in the Chamber of Commerce, and...I'm well aware, we've talked a lot about the community sign, and it was decided in that group, particularly in the subcommittee headed by Cathy Dunlap, that they don't want the City to pay for the sign, they want the community to pay for it themselves. They've not asked for any money. And I don't quite understand how you can earmark money for a sign that we don't know who's going to own, we don't know when it will be put up, we don't know who's going to maintain it and we don't know where it's going to go. So you got \$25,000 that ain't going to be spent this year anyway. Why not change the designation and get these - get this study going and get these people taken care of. You know, Mr. DeOrio, you talked about grandstanding, and what you did with that article in the paper was the biggest grandstand scheme I've ever seen. 'Cause nobody asked you for that money. You did that on your own. It's not true, 'cause I talked to Cathy Dunlap.

Mr. DeOrio: And I talked to Cathy Dunlap and Ron Kindy and a...number of other Chamber people and just to bring you up to speed on how this - on...

Unidentified: It's true.

Mr. DeOrio: how this developed. I talked with the Chamber, going back into, oh, sometime in the last...fourth quarter of last year. I think that was it, that what - what is it that City - City Council can do for the Chamber, are you guys working on anything, what's the plan. They gave me a list of their top 3 priorities, the Chamber...

Mr. Foltz: Mr. Davies, we're not going to have a debate here.

Mr. Davies: No, no, I'm just going to say, talk to Cathy Dunlap because...

Mr. Foltz: You had - you had your public speaks...

Mr. Davies: they do not want the money.

Mr. Foltz: he will address your concern and then you can talk to us after the meeting. Thank

Mr. DeOrio: And approached them about it, they said that the community sign was something that they were very much still interested in, would like to see it work. I spoke with Ron Kindy who...gave me some materials that he had presented, had saved over the years to show the history of this...effort, to see where - identify areas where it had failed, I had researched this through looking at the Council records, examining the arguments that were made over the last four years to see if...there was some way we could work around these objections. One of the objections was...if the City owned the sign, there were free speech issues, addressed that with Cathy Dunlap and...the Chamber agreed that they would - they would take responsibility for maintaining the sign, they would take responsibility for the content. That was another objection. We talked about - another objection was where would it be located if it was going to be on city property, that brought up the same free speech issues. I spoke with the Law Director on numerous occasions for many lengths of time to work out some of these details. We felt that it was best that that be located on private property. Consulted with the members of Council to see if that was the -- they would not have an objection to that, got back to Cathy Dunlap and said, and convinced her that Council felt...that it would be best if it was on private property. The other issue that was brought up and some of these eventually did get discussed on the floor of Council. You may not have been here at those meetings, but in any event, they were discussed, we talked about finally, last time there was an effort to spend \$50,000 on this project. Some of the Council members at that time had said that...they wanted to see more community buy in, they weren't sure that some of the pledges that were made would ever be collected upon, so... I had a suggestion that we...based upon our budgetary constraints, that I felt 50,000 was not something that was going to work but 25 might be a number that Council could live with and then with the 25,000 we would...propose it on a matching basis. I'm not sure if the Chamber has finalized or the design of the sign or - or where they are in the beginnings of the stages of putting this project together. Maybe the sign they design and come up with only costs 40,000, I don't know, but the pledge that -- that we were looking at was at we would have to have, you know, real money collected from real people in the community for this sign before we were going to put any money into it. I spoke with Finance Director at length about if we could establish, it would be best to verify these funds that if the Chamber established a separate bank account somewhere opening it up in the name of the "build the sign foundation" or whatever they want to call it, so that deposits could actually be made into that account that we could witness to say that it was actually money being raised. And then the most of our commitment would be \$25,000. I have been in contact with the Chamber on a regular basis, they have not indicated any change of heart to me. I spoke with Cathy Dunlap as late as this weekend, and she indicated that she would like everything to

remain the status quo. Now, I know that the...Berry Kindy and Ron Kindy and Jim Dansizen and the individuals that came up and made a presentation before this Council have not changed their mind. I don't know what capacity you're acting in behalf of the Chamber or if this is just your opinion and if it is, I respect your opinion, I receive phone calls from people all the time that they would allocate things a little differently. That's fine. We can have a difference of opinion on that, I — the budget represents many things to many different organizations of which the Chamber is an active partner in this community and I'm going to continue to foster that relationship, so we work together on various projects of which this — this one that begins a new chapter. Thank you for opportunity to respond.

Mr. Foltz: Thank you, Member DeOrio.

Mr. Repace: Doug.

Mr. Foltz: Member Repace.

Mr. Repace: Yeah, let me - let me say something. Mr. Davies, I'm also in those meetings, and I can remember early on when discussing this community sign it was mentioned at those meetings it'd be nice if the City could – could put some kind of funding in place for those signs. There were - there were members of the TAP committee that - that have addressed Council. It was agreed to - to match certain dollars. You know, if - if - if that committee says that they don't want any part of - of Council putting any - any money towards that sign, you know, I think that collectively, they should either come here or - or contact Mr. DeOrio because he was left with the impression. And second of all, you - you - you mention about grandstanding, that article that was in the paper was an article, was an interview that took place probably a month before that was even put in the paper. And in - it's been brought to - to least to my attention, you know, everybody can have a disagreement. There's nothing wrong with that. But I don't think this is anything that should become an issue of where - where people should be humiliated or bashed over it. And I do know for a fact that you have done that to Mr. DeOrio. In fact, you've done it to me too. But you've done it to Mr. DeOrio. All he's trying to do is his job. And like I said, if it's brought to his attention by that committee, which - which I know he has just talked to the - some of the committee members, because Cathy and I had a discussion over it. And honestly, I got the same impression that you have. That maybe that wasn't the right thing to do with that 25,000. I got a hold of Pat, and I said I'm a little confused here, I think - I think we need to find out if this is the right direction. Pat said he would contact some of those members, and I just heard now, he -I - he obviously did. But I - I think if people have something to say, you know, any issue can - there's no issue that's - that's too big or - or too little that can't be talked out. Very easy to just discuss it and then let's do the right thing. It doesn't have to become a situation where people are - are getting upset with one another. Just talk about it. Let's make it right, whatever it is.

Mr. Foltz: Alright, thank you for your comments, and we'll wait and hear back from the Chamber if that's their – their direction they want to go in now.

Mr. Osborne: Chuck Osborne, 307 Fairview Street S.E., North Canton, Ohio. It's very...disconcerting and unnerving to hear that...this City's discussing an agreement now with a township on the east side of the City as considering, you know, how the one on the west side of the City was...went down in flames. Why this City would even consider something in this nature. When you start down this path, of setting up an agreement or a CEDA, you're basically saying, we're satisfied with our borders, we're never going to grow, and we're just going to take what we can get. There are many things that are said up here that I think are factually incorrect. Mr. Snyder, property taxes, as you, I'm sure you know, go to the school district. Property taxes don't vary with municipal boundaries, they vary, I guess, or they – they – depend on the school boundaries, school district boundaries.

Mrs. Magel: Speed it up.

Mr. Osborne: And about three quarters of your property taxes go to the schools, so there's very little, in terms of...property taxes for the cities to fight over. They support school systems. So you can take property taxes basically out of the equation. Mr. Foltz says...this is a win — win for Plain Township. I don't see how that it is when...Plain Township...residents are going to end up having to pay an income tax, and yet they're really not part of the City. And I guess they get very little in the way of services. You're basically wanting to take taxes from them, but you're not willing to give them much in the way of services. Mr. Repace, you seem to kind of, by association, imply that the Law Director...is behind this agreement. I think Mr. McFarren, if you could correct me if I'm wrong, you simply draw up whatever contract Council asks you to draw up. Is that correct?

Mr. Foltz: Mr. Osborne, just finish your comments then we'll address them when you're finished. Thank you.

Mr. Osborne: Well, I think, Mr. Repace was trying to imply that the Law Director...is behind this, supports this, the Law Director does not set the policy of the City. He's not elected official. And whatever his decision is, or his feelings are on this issue, are irrelevant. You are basically throwing in the towel on a ballgame that hasn't even started when you start down this path. I don't know why this City is not highly, highly embarrassed. You have the City of Canton every week, we read about an annexation here, annexation there. We've watched the City of Massillon, probably double in size in the last twenty years. And we see other communities around us annexing. But for some reason a community that desperately needs to grow a little bit, if you're going to find a place to land a business, is doing nothing. Concerning...Mr. Wise's comments at the - there's some areas off of Salway that would like to annex in the City. As I blurted out, and I apologize...at the Committee Meeting, and I might like to add that nobody counseled Mr. Giavasis for speaking out of the audience. I don't think your policies are being applied fairly to me up here, but anyway, you annex residences, you get income taxes. To sit here and say we get nothing from that, I think, and – and everybody else sits up here and just lets it pass. You do get income taxes from those property owners who have jobs. And if they're elderly, like you quickly thrown in, we don't know that for a fact, you just said they're mostly elderly, we don't know that. Well, when they die, you get estate taxes. So to sit here and say, nah, that doesn't work for us, we don't get anything out of it, how can any of you...you remaining six people, sit by and say oh, he must be right. When you know that isn't factual. Although I guess Mr. DeOrio did second you, yeah, we don't get any income taxes from...annexing people. Mr. DeOrio, I think you know better than that. There are income taxes when you annex areas, property, residential properties.

Unidentified (from audience): try to...inaudible...somewhere else.

Mr. Osborne: So I hope this City doesn't go down this path, I'm quite alarmed that...Mr. Repace appears to be abdicating his responsibility to the citizens of this City first, and pandering to his political friends, who by the way, we've seen them parade in here supporting Mr. Repace, and it's no wonder why he - they won't - they're supporting Mr. Repace, he's up here working on their behalf.

Mr. Foltz: Mr. Osborne, you're out of order. You're making allegations. comments.

Mr. Osborne: I said it was appearances.

Mr. Foltz: Finish your comments, please, without that rhetoric, we don't need that.

Mr. Osborne: Well, there's been an admission that Mr. Giavasis has been meeting with...Mr. DeOrio, Mr. Repace over the past several months. That is suspect to me, and I would think it looks suspicious to a lot of other people as well. This City is providing services outside its boundaries, the law is on it's side, we should be doing some annexations. There are several areas of Jackson and Plain which they cannot service...efficiently, and that's where we should be able to sit down and talk with them and see about conceding some of that area. It would be good for them and good for us. But to throw in the towel now, before we've even thought is is just unbelievable. Thank you.

Mr. Foltz: Okay, anyone else like to address Council this evening, or ...inaudible...comments?

Mr. Repace: Yeah I want to ...

Mr. Snyder: I have one comment if I may. Two things...

Mr. Repace: Go, go on.

Mr. Foltz: I'm sorry sir, you'll - you'll be next after Council's comments.

Mr. Snyder: Number one, the City only receives 9% of the...real estate taxes, the Township operates on I think about 24 - 25, which we're under the new Ohio law obligated to return to them, and relative to the income tax, there is reciprocity in this state, the majority of the people do - there - live - do not work in the City, so consequently the taxes will immune to the municipality that they work in, so it actually would cost us money to annex rooftops into the City at this - under the present situation.

Mr. Osborne: Well you can change the law on that.

Mr. Foltz: Please remove him from the proceedings. You're gone. You're gone. You had to push it. But finish your comments Member Snyder.

Mr. Snyder: Thank you...you know, and relative to that, the thing is, in my experience, that I've sat here as councilman, when we've done ambush annexations, we've ended up in protracted litigation, which far exceeded the actual amount of money that we received in income tax or any type of tax that we would have gotten had it been a cooperative agreement of some sort. And I mean, really, if we're going to start thinking more of a business aspect, rather than a government to where we just spend, spend, spend, we have to do it predicated on the ability of return on investment. And if there's not an adequate return on our investment, it really, to tax our safety and services additionally, which will result in increasing either the income tax or some type of levy...and I think at this present time, it's all exploratory anyway, I don't know that we're just looking at every venue we can possibly look at. That's all I have to say, thank you.

Mr. Foltz: Okay, thank you Member Snyder. Member DeOrio?

Mr. DeOrio: In - in - yeah, to just dovetail in - on a couple things. The City of Canton...yes they have done annexations, as Mr. Osborne had said, but they haven't thrown in the towel. They're also doing a CEDA out there in... East Canton with Osnaburg Township. And it looks like they're going to be fashioning some type of other agreement...with Plain Township regarding the Park Farms, so I mean, it's - it's something that they're approaching and looking at as well. You know, one of the differences between - though between Canton and Massillon is by who we're surrounded by. No disrespect intended to these other townships, but you know, Tuscarawas Township, Sugarcreek Township, Bethlehem Township, that surround Massillon, they don't have a lot of money. And out there in East Canton, Osnaburg Township, and these are the smaller townships in the - in the county. They don't have a lot of financial resources to fight litigation. That's not the case with Plain and Jackson. I mean, if they're, if if they do - if they want to object to an annexation, they'll fight it in court, and we'll be tied up for years...with it. And then finally, I'm sure Member Magel would want to say this, but...you know, if we'd - we have to take a look at...the - the in - the investment payback...scenario that Jon was looking at, and part of that is also how it affects our water rate. So you're taking basically outside customers and making them inside customers and cutting their rates significantly, that's good for them, but it - it also lowers...the revenues to our water fund. Thank you.

Mr. Foltz: Thank you. Member Repace.

Mr. Repace: Well I want to clear the air on a couple things. First of all, Mr. Giavasis was an invited guest, as...

Mr. Foltz: As you noted.

Mr. Repace: And he was ask - he was asked a question, he responded to that, so he didn't blurt anything out. Make that real clear. Second of all, Mr. Osborne one - once again, is trying to accuse me of violating a law, which - which there - there is no violation. I think that needs to be made clear. Not trying to insinuate that the Law Director is in favor of this, but I - I think the Law Director's smart enough to - to say that if this isn't a good...document, if this isn't the right direction to go, I think he's going to say that to us. We - we finally are trying to do something different. We're trying to do something to move forward to bring revenue into this City, as I have already said. You know, Mr. Osborne doesn't seem to want to try to do anything different, make - and make changes. Try and go into a positive direction. I've yet to see him come up to this microphone and agree with anything. Just because he says it, that's the way it's supposed to be. There's people up here, levelheaded people, on both the Administration and - and...this side of the table, and Council, that are reviewing this. This is something we need to do, this is something we need to - to - to attempt to - to - to enter into this agreement. This agreement doesn't lock you in for life. This is an agreement that - that allows us to make change, to move forward, to bring revenue into the City. If it doesn't work out, there's an escape clause. I mean, it doesn't take a rocket scientist to see that. So, that that's - that's all I got to say.

Mr. Foltz: Any other comments from Council? Member...Finance Director Julie Herr, I had a comment. The Sanctuary CEDA agreement that we just recently had with Plain Township, would you consider that a profitable one to our - our general revenue stream?

Mrs. Herr: When I did the calculations, yes it was.

Mr. Foltz: And it was - that made it very favorable for us to vote for that...

Mrs. Herr: Yes.

Mr. Foltz: and as I remember, as a council member, so that being said, I look forward to any future CEDA or JEDD agreements with - with Plain Township that are negotiated in good faith by both sides as - as we discuss at the ... committee meeting. That said, anyone else like to address Council this evening? Yes sir.

Mr. Spencer: Good evening. Betty and Neil Spencer, we live at 221 Summit S.W. Betty and I want to thank the Council for your action last year that resulted in our portion of Summit Street getting new 8" waterlines. They're great. Thanks especially for the way you handled driveway aprons and sunken sidewalks. We hope that the curbs and gutters that were...petitioned last year might now be possible this year. Thank you.

Mr. Foltz: Okay, thank you for your comments sir. Always refreshing to hear some positive... responses from our - our residents, isn't it?

Mr. Snyder: Cute guy, huh?

Mr. Giavasis: Lou Giavasis, 2600 Easton Street, Canton, Ohio 44721. I'm President of the Plain Township Board of Trustees. I've sat back tonight and I've listened to a lot of pros and cons on both sides of the story. And I commend this Council and Administration first - first of all, hearing out the things because I know what it's like to sit up there and hear people talk that don't necessarily know what all the facts are, just what they perceive to be the facts. I think this is the first time that I think...a Trustee from Plain Township has ever been able to walk into North Canton City Council Chambers and not having to worry about having an armed guard with him when he walked in to the - the Council. And it's a very refreshing thing for me to be able to come into Council and look at the Administration and Council as a whole, and be able to talk to you folks openly about areas of cooperation, because that's what the future holds for both of our communities. I think Council, and I don't want to be redundant by what was said, but nothing is going to be...accomplished by all the legal wrangling and the appeals and you spending the legal fees and us spending the legal fees, where we ultimately want the same thing. We want the best for an area, whether they want to be annexed or the Township wants them to remain part of the Township. Just to give you a perfect example, the....the Heatherwood annexation that – that – that – I think was discussed earlier. If the City would take that piece of property and there's more to it than just taking over the roads and the infrastructure. You're going to extend waterlines, which I think is, my belief is what the main issue of those residents want in the annex into the city is going to be. But when you factor in what the Ohio Revised Code says, it's not just a portion that the city's going to collect once they become part of the township. The Revised Code is very specific. They're going to – the city is responsible to reimburse the township their full tax valuations as if it was never annexed. That means our police, fire, road, any other levy that we may have on the ballot including our inside millage. Now the City of North Canton, you guys did a great job, in my personal opinion, I'm biased towards it, you became your own township to save yourselves from spending \$36,000 a year needless tax revenue to Plain. Why in the world wouldn't you sit down at the table with the township whether it be Jackson or Plain, and work on an agreement where you don't have to pay those taxes? And the reason why Plain - Plain Township sent a bill to the City of North Canton, and I'm apologetic for it, but statutorily I was obliged to do that. And the reason why there was such a disparity in the amount that the City of North Canton owns from annexations that were done unilaterally versus Canton, is because our annexations with Canton were done through cooperative agreements. And a cooperative agreements, the township border, Hoover Township in your case, wouldn't extend into Plain Township. That allows for those taxes still to be collected by the County Auditor. That means that the property owner is still responsible to pay for those taxes. If you annex it outright, that means you're taking Hoover Township into Plain. Those taxes drop off the tax duplicate and the only recourse for reimbursement if any, comes out of the City's general fund. So when you factor in your cost to an annexation, whether it's commercial or retail, the retail's going to even be larger, 'cause if you take an area like Walker's Mountain, which our tax revenue's in excess of \$400,000 a year. You take 80% of that for the first three years, the City's going to pay Plain Township over \$300,000 a year, just to annex the hotels on top of the hill. There's areas that we can do this in that's not going to cost the City that revenue, it's going to augment your budget, our budget, we're all in the same predicament, financially. But your expanding outwards, but the same token, you have to expand your cities, whether it be safety services and things like that. I heard talk about police officers. You can't do that without the additional revenue. If you're not bringing in the revenue and Plain Township's collecting the revenue, how are you going to extend those services? The whole thing is about cooperation, and I really want to commend this Council as a whole, and Member Repace because...I take a little bit personal that I'm here doing this as a personal and you know, favor to...any one individual. I'm doing this as a resident of Plain Township. My mother is a resident of the City of North Canton. She's a taxpayer here also. So I have an invested interest in that also because of my parents. They live here. I just so happen to live in Plain Township next door. We could all go back in time to previous administrations where we couldn't stand in front of each other and talk civilly and talk about areas, about cooperating. We're not talking about entering into any one particular agreement here, we're talking about sitting down, agreeing to agree, that we're going to look for areas contiguous with North Canton, it's going to assist the City financially, and is

also going to assist the Township financially. And that goes well beyond just the CEDA or JEDD. We could augment our — our safety services. We could do immediate response agreements, like we have with Jackson Township, that could augment the North Canton Fire Department and visa versa. There's areas of Plain Township that North Canton could augment ours. There's things we could do with our police services. There's a number of different things that we could do with that agreement once it's passed beyond just a CEDA or a JEDD. And I think this Council, in the paper, and publicly should be commended for finally sitting down at the table and recognizing that fact, and it's going to do what's in the best interest of their constituents. Thank you very much.

Mr. Foltz: Okay, thank you. Anyone else like to address Council? .

I personally believe that any advertising that we can do with current events going on in the City...which will...bring revenue to the City or to the business places in the City's a good idea. I always did think that. I'm not even going to get into the idea of discussing the cost of that sign, however, I have to agree with Mr. Davies, that if there's \$25,000 involved from the City, I feel that probably that should be directed in...in the direction of people down on Lipton also, if it's possible. The only concern that I really have about the whole issue is a safety issue, believe it or not. And I...brought this up a couple years ago when this was being discussed also. I drive probably as many miles in this city today as I used to ten years ago. And the concern that I have is with the increase of traffic that we've got...and driving in front of and behind people, who are talking on cell phones and putting make-up on and that sort of thing. Is there anything I can do about that? Probably not. The issue I have with the sign is, if we put a sign in some sort of an area, where it's going to be distracting to any persons driving, it's just... I'm sorry, an added hazard. I think that that's the only thing I want to take into consideration. When we discussed this before, or the Council discussed it before...Bitzer Park and the City Hall where talked about as possible locations to put a scrolling sign, you know...neat idea and everything, however I feel that a safety issue should be taken into consideration also. So, you know, having said that, I think, you know, in all the consideration that's being given to...erecting a sign somewhere in the city, and I haven't heard any ideas where this could possibly be placed now, I would be totally against Bitzer Park or the City Hall obviously, but if - I think that should be taken into consideration in the placement of something like that as far as traffic safety. Okay? Thank you.

Mr. Foltz: Okay, thank you, thank you.

Mrs. Garcia: Yes sir. Gee, welcome home, it sounds like the elections coming up pretty quick, huh? I'm kind of confused, and - and I'd like to remind you that one time I stood here and begged you to be careful of the CEDA thing that you were doing and — and annexing the Sanctuary and all that stuff. Remember? And I'd like to ask Jon to repeat what he just said. Because he used to stand up here and tell you we got to annex that place, we're gonna get millions of dollars in income. So, Jon...you want to tell us that fairy tale again?

Mr. Foltz: Mrs....Garcia, when you're finished, he'll respond.

Mrs. Garcia: I'm finished.

Mr. Foltz: You're finished? Thank you for your comments.

Mrs. Garcia: And I'm glad to be home.

Mr. Foltz: Okay.

Mr. Snyder: I still think, Mrs. Garcia, as you like to refer to me as a snake oil salesman.

Mrs. Garcia (from audience): Yes.

Mr. Snyder: I think the deal at the Sanctuary is still very profitable to the City. First of all, it was a negotiated annexation. So the property taxes in fact stayed with the township and the other stayed with the North Canton City School. And the projected...income taxes, I think, \$157,000 plus, if you recall, you're a direct beneficiary of that, why we were able to repair the Holl Road lift station, by my efforts, to raise the tap-on fees to a thousand dollars on the sanitary sewer. Had I not done that or spearheaded that, that Holl Road lift station would be overflowing right today and...the people would — would — a lot of people have sanitary sewer problems, would have problems, that in fact made that fund Holl and put additional dollars. But it was a good negotiated annexation, but that was a negotiated. Relative to the water, I still feel very strongly that the City should control the waterlines, however, that had been done prior to any negotiation to annex the property, so we had no control over that. So I hope that answers that.

Mr. Foltz: Thank you Member Snyder.

Mrs. Magel: Wait – wait I'd like to ....read Mrs. Garcia's mind. I think what she was going to say is, it was promised that Holl Road was going to be - Holl Road station was going to be eliminated. We promised her that.

mayor, what his position was with regard to adding the detention ponds which had been designed by the City in Price Park, and he was against it. The only question I have for the Mayor and the Administration is, is it time to go back and revisit that based on your recent statements. Thank you.

Mr. Foltz: Okay, thank you.

Mayor Held: If I could...

Mr. Foltz: Any comment Mayor? Yes.

Mayor Held: Yeah, I'd like to comment on that. And I appreciate what you brought up Mr. ...Schilstra. Mayor Held: I'm not sure if - if both have been completed yet at this point. But...at least according to the Army Corp of Engineers, we're going to see relief down in that area.

Mr. Schilstra (from audience): That's not...inaudible....

Mr. Snyder: Might get out of here by 10:30.

Mr. Lane: ...inaudible...

Mrs. Schilstra: Mary Schilstra, 601 Linwood. My husband and I went to the ... inaudible ... thing, for the retention basin, over on Aultman? And the Colonel, the head guy, in the uniform outfit and I had a discussion and he told me you do know this will not solve your problem. You may not have a foot of water in your basement, but you'll have half a foot of water in your basement. And if there's going to be continued growth, it's not going to get better, and yes, I'm glad to know we're going to have a foot of snow 'cause that foot of snow's going to have to melt and then we - we're gonna have rain. And then we'll just continue to have the flooding. So I think the City needs to put a little pressure on the County, they need to put...pressure on the Army Corp of Engineer, and you can't wash your hands of this, 'cause you know what's going to happen, so...

Mayor Held: Right.

Mrs. Schilstra: but yes, I remember talking to the Colonel who said, this will not solve the problem, so.

background and some marketing information on this product, and we do hope that sometime it - it will - will happen. I've been at this 2 1/2 years and so far haven't found...the number of investors. We do have people who can make the product and will make the product, and I just spoke last evening with the inventor and the - the President of the company in Melbourne, Australia. He updated me with some pretty good news. It's kind of good, there's only one little teeny negative. As before, I mentioned that Canada seems to be the forerunner in showing interest in this product. The Canadian people would make it for Canadian and maybe ship it down here with NAFTA getting stuff down here free, etcetera, etcetera. But also there's another country in Europe that's interested to serve Europe, and there's...the the...Australian government, an Australian...forces have begun to - to get more and more active and it looks good in Australia. And then, lo and behold, China is interested. And I, maybe Mr. Repace and I can chat sometime about that and see how, somehow that might fit in with what's going on there. We'd love to see a - a nook at the Hoover plant initially with 20 people, good paying positions, eventually 200 persons, again, high paying positions down there. So, we feel good about that. The other issue please, is Auburn Knolls. Things aren't too good down there. There's a lot of people are very upset. I mentioned before they're stressed. I know these people well. They're people, they don't sleep. They're people who have crying spells, property values continue to go down. The highest one loss so far is \$110,000, the average is \$72,000. And the biggest problem in my mind is that there are about 60 families there of the 83 who live at Auburn Knolls, 60 families are in the position whereby if and when they pass on, this is the biggest asset, and many have told me this, and I've seen some tears flow, and their children would - are going to lose from this too, that property value. And the - the - the - the value, I'm sorry, the problem with property values was brought up at a planning commission meeting more than once, early on, and that if it's going to affect property values, this is something maybe shouldn't happen. That was made in a general sense. I did find something interesting just the other day, that has to do with Magnolia Estates, which, as you know, is the development just south of Auburn Knolls, which originally was part of the some 50 acres of the Hoover property, 34 acres became Auburn Knolls, and the 10 to 12 acres below that became Magnolia Estates. It seems in...I want to be sure I get my dates right here, I spoke to Mr. Roush, as you know, was City Engineer and later Administrator in 1979 I believe up to 19 was it 1900, Jim? Mr. Roush left?

Mr. Benekos: to 2000.

Mr. Covey: 2000? 2 - yeah, thanks. I asked him about this because his name was on it. But it so happens that...the ...the subdivision regulations of the North Canton...City calls for a developer donating 5% of that to park land or some recreational value to the people who will be moving into that area or - or - if you don't want to do that, just pay the city...X dollars for that - that - that land if you want to use and not give it into park or recreation for the people. That firm Spartan decided...it would pay the money and it did pay \$19,000 to the City of - of North Canton to start the development there. Now, bringing up to date, Mr. Visconsi who shelled out a million dollars to the Hoover Company to buy that land, he said he did not want the South Main area, anything built on that. He wanted it to stay green. On the other part over there that on Northfield and Easthill, which is going to be two more buildings, he said, I don't want anything there because those four private homes there, ranch homes, I don't want to disturb them, they've been there a long time, and let's keep it that way. He was a pretty nice guy. But what happened, somehow this got lost in the shuffle, and so the developer said, no, I'm going to go ahead and put two apartment buildings on South Main, I'm going to put two over there, even though that land...was supposed to be free from any building at all and tomorrow I'd like to meet with key persons in Administration and see if there's not a document to match the document for Magnolia Estates that shows that Mr. - Mr. Visconsi and the people who laid out Magnolia...sorry, Auburn Knolls, did in fact say, we want to keep this green. And I think there's some paper somewhere, in some file, and I'd like to look in that tomorrow. At the last meeting, December 11th I suggested that maybe...to Mr. - Mr. Lane that we ask the Law Director take a look at whether or not the Council can somehow overrule or - or decide or do something, something to - to save the situation at Auburn Knolls. And I chatted with Mr. McFarren Friday night briefly and...I'm not sure yet he's going to...an actual decision forthcoming on - on that, on whether...

Mr. Foltz: Well, when you're finished sir, we'll address all of your comments, okay, to be fair to everybody here.

Mr. Covey: Oh, okay, okay.

Mr. Foltz: Thank you.

Mr. Covey: Of course, I understand, okay. I did read the city charter four times, and I read the – the North Canton zoning ordinance, chapter 1175 as you know, part 09, and after reading, if you read any of these things several times, it suddenly it all gels. This was the intent, why else would City Council then put out this development plan review 1175 which says in six...paragraphs in effect these buildings just don't fit. And in February 204 (2004), at the

planning council meeting, I was here of course, that the chairman, the assistant chairman, and one other member all said in effect this isn't neighborly, these buildings don't fit, why – why we putting up these apartment type buildings and – and ruining it? One final comment, if I may, we – we – we aren't green as we used to be. Auburn Knolls as you know is a square mile exactly. It is green all around. And people coming from Belden Village coming north into town, they see a lot of green. That green is going fast. You been there lately? This week? Last week? A lot more trees are coming down. It's a – it's a shame. If you get on Google, Google earth, how many here are familiar with Google earth? Good. It's – it's the most fascinating thing on the internet. If you don't understand it, ask your kids or grandkids, they'll – they'll show it to you. Anyway, if you get on Google and I've done it, and – and click up what downtown Canton, go up Cleveland Avenue all the way, come into North Canton, keep going. There's no green anywhere anymore. Except there was a nice piece of green at Auburn Knolls, it's – it's going fast.

Mr. Snyder: Gone.

Mr. Covey: Thank you very much.

Mr. Foltz: Okay, thank you sir. Anyone wanted to address any comments?

Mr. Lane: Yeah, Randy, you want to...because I-I following that meeting that Mr. Covey talked about I did do a written request on that, and you and I have chatted about it a couple of times off the record, but I didn't know if you were any more closer to giving us an opinion or not.

Mr. McFarren: Mr. Covey and I have discussed this ... situation a number of times at length, most recently Friday night. I guess, I don't remember what day it was but I do remember we talked for about a half, excuse me, about half an hour. The gist of the conversation went went this way. What Mr. Covey is asking me to do is to review every decision that was made by this Council and the building and planning and zoning and all of that kind of stuff, and you know there are times where your Law Director's opinion means something, and there's a time where it doesn't mean anything. And there's a statute of limitations on almost everything in our society except murder. And if there was...an error that was made, not just a misjudgment, if there was a legal error that was made at some point in time, thè remedy for that would have been an administrative appeal under chapter 27 of the Ohio Revised Code. We're talking about decisions that were made years ago. Not 30 days ago, 60 days ago. Mr. Covey and I've discussed the fact that according to him, that there is a deed restriction that limits the density on this area and I advised him that that was his best remedy. And in - in fact, if it exists, he has a readily available remedy...that - that is peculiar to him and to anybody who resides on the land that was originally part of that -- that...deed restriction. And that's a private matter, has nothing to do with zoning, has nothing to do with what's right and what's wrong with the city, that's a private matter. If there was a restriction on that property, it runs with the land, it's for the benefit of the property owners. This is just one of these things were we can argue until the cows come home about whether this is a good decision or whether this is a bad decision. The facts are that the decision's been made long time ago, and nobody has given me the slightest shred of information that would cause any action on behalf of the city, let alone for me to attack decisions by everybody involved in the whole process.

Mr. Foltz: Okay.

Mr. McFarren: I've looked at this thing repeatedly, if somebody comes up with something new I'll look at it again, but there's nothing new in the equation.

Mr. Lane: Yeah, I think the only, the only question that I had asked was that whether or not the Council had the authority to override anything on Planning, beyond what specifically is pointed out in there, things along the line of street closings and – and zoning matters. But as far as the site stands...

Mr. McFarren: Not in this matter. Mr. Lane: Yeah, I think it was the...

Mr. McFarren: The horse is long since out of the barn.

Mr. Lane: the predecessor. Okay.

Mr. Foltz: Okay, with that...

Mr. Snyder: Well there is, there is actual, that's the way it was drafted, that you know, council, less council has privy to review it, it has no power to override, by super vote or not, and that's – it was designed specifically to keep it apolitical. And unfortunately, you know, you have to change the subdivision to regs to change that.
