7. Recognition of Visitors

Mr. Snyder: Thank you. One thing, it was brought to my attention last week, pursuant to the rules of council, we will have a recognition of visitors at the beginning of the meeting. The final call for business at the end of the meeting is that of business of the council or of the administration. My apologizes to the public. If you wish to speak to the council you must exercise that right at the beginning of the meeting during the public speaks. Is there anyone in the audience wishing to speak to the council? Mr. Osborne.

Chuck Osborne: My name is Chuck Osborne. 307 Fairview Street SE, North Canton, Ohio. Over the last few weeks I have learned of several seemingly illogical decisions made by Mayor Tom Rice and I would like the Mayor to provide an explanation in this forum about these decisions. And I will provide you with a copy here while I'm reading this. First, legislation to study flooding issues in this city was passed by council last Fall and he refused to sign it thus

delaying action by the city. Later he refused to sign the contract with the engineering firm that was hired to do the work. Are these actions in the best interest of the citizens of North Canton? Second, he refused to participate in an opportunity to bring increased tax abatements offered by the State of Ohio to the City of North Canton. As I understand it, this opportunity involved a request in writing declaring that North Canton met criteria for a State of Ohio designation that would allow state tax abatements for equipment purchases by manufacturers doing business in the city. Actually it would be increased tax abatements over and above what are allowed now. Wouldn't a program such as this be instrumental in retaining the Hoover Company here in North Canton and bolstering our economic development efforts? Why would the city refuse to participate in a state sponsored program such as this? Third, what benefit is it to the citizens of North Canton for the Mayor to remove longtime dedicated members from the North Canton Park Board? These members were highly endorsed by the North Canton City School Board and have served this city with dedication. Fourth, does it serve the city to have the search for the economic director shrouded in secrecy and controversy? How is this new employee going to serve as an ambassador for the city when his very employment appears clothed in deception and mystery? What is the city trying to hide under the guise of courtesy and protection of privacy rights? Lastly, what benefit is it to the citizens of the City of North Canton to remove our former City Administrator, Mr. David Held? The Mayor stated in his interview to the Repository Editorial Board, in the Mayoral Campaign, not much more than 90 days ago that he trained Mr. Held and that he was doing a great job for the city. I was one among some of the individuals interviewed for that position in this interview from the Repository. What has changed in the last 90 days that would force such an abrupt change for our community? The citizens of North Canton deserve a logical and honest explanation for each of these decisions. And I'll give you a copy here so the Mayor can address each of these. Won't you just pass it on down? Mr. Snyder: Alright sir...

Mr. Osborne: Here i'll ...inaudible...

Mr. Snyder: Are you asking me to...

Mr. Osborne: I'm waiting for the Mayor to respond so we can hear the reasons for these decisions.

Mayor Rice: Well number one, I think this - I'll defer to the President, but I think this is public speaks at this point in time. Many of these issues I plan on addressing during my report period at the end of the meeting if that would suffice.

Mr. Snyder: Will that do Mr. Osborne if he answers at the end of the meeting?

Mr. Osborne: Well in the past there's been a give and take generally in the public speaks. This body responds to the questions.

Mr. Snyder: Well I would only say sir, I - unfortunately I don't - I'm - myself and I think my colleagues, none of us are in a position to answer these questions. Out of respect of the Office of the Mayor, I will allow him to speak at the close and address these and we'll make sure each one of these questions, if he's so prepared to address the answer, we'll make sure you get an answer at the report part of the meeting. Will that be ...inaudible...

Mr. Osborne: Well if he's made these decisions I hope he is prepared. Because he's already made the decisions and obviously the logic behind the decisions should already be formulated. So I hope he does indeed have good sound arguments for these decisions.

Mr. Snyder: Inaudible... thank you. Anyone else wishing to speak to the council. Sir, step forward, state your name and address for the record.

Jim Steigerwald: My name is Jim Steigerwald. I live at 1437 Northfield Avenue SE. My concern for tonight is we've become aware of the widening project that's going to happen down on South Main there at the Everhard area. And our concerns in the area are going to be the detour that's going to happen for - I don't know what the detour will be, but I'm sure there will be a lot of diversion of that traffic. Our concern is in the area and I speak for several of the residents on that road - on Northfield. As after you come off of Knoll, Northfield as it curves around, they have no curbs or anything like that it's straight from the pavement into the grass and on that curve it gets pretty dangerous right now. Our concern is we just wanted to know if the plan is in effect to take care of that street prior to ODOT starting their project and if there's a time that you know I might be able to tell the residents to just kind of relax a little bit. This is their priority and this is you know, you guys are going to feel that this is something that you can do right by the residents before it gets out of hand when the detour end up - that's our biggest concern in the area is a lot of traffic and we think that maybe you can correct the right before it becomes a wrong. And that's all. I don't know if there's a question and answer type of thing or if there's an answer that you guys may have or a detour or some solution that I might be able to go back with or just something that allow them to know that everybody on the council knows now that we're concerned about that now. I know it's even you know a year away, but I don't know when projects start and I don't know when they get planned or anything like that. So ...

Mr. Snyder: Well sir, as not speaking for the councilmen, nor the administration, but there is a I believe on tonight's agenda, the engineering for that area to correct the storm water and as part of the streets. A well as when it gets closer to the actual time to finish the design to let the bid for that, should it go through, there will be adequate protection placed there I'm sure, both by the police and by proper barricades to protect your property as well as the children that live there and the pedestrian and the vehicular traffic that goes through there. Sometime in February, we're not sure of the date yet, at the end of the council meeting we want to have the residents from Magnolias and Auburn Knolls and the people on his side of that barrier, to come in and we want to show them that project that's on the books. And to be honest with you the detour hadn't even entered my mind yet because we hadn't even bid the project. So at that point in time anybody who lives over there is going to be invited to come by and you can express your concerns to Mr. Benekos and to us as well. So it's not a train that's left the station by any means.

Mr. Steigerwald: Right ...inaudible...

Mr. Lane: And we have some of the same concerns that you do and we just want to get on record as well. So we're shooting for some time in late February after a council meeting...

Mr. Steigerwald: Inaudible...

Mr. Lane: At the very latest early March.

Mr. Steigerwald: And that was my only purpose...

Susan VanVranken: 521 Church Street SW. Mayor Rice, I just have a few questions concerning the Recreation Board. We met this evening at 4:30 and I was shocked to find out that two of our members were no longer with us. I was wondering if you could explain to me and the citizens why they were not their terms were not renewed.

Mayor Rice: Again, you want me to ...

Mr. Snyder: Yea, would you ...

Mayor Rice: Can I address those at the end with the rest of them?

Mr. Snyder: Mrs. VanVranken, would you - would it be an inconvenience if we waited till we go through this and at the end of the meeting at his point he'll address ...

Mrs. VanVranken: Okay. I also wanted to know why the new members that are supposedly taking Mark Cerreta and Debbie Goldthorpe's positions were not at our first meeting of the new year at 4:30 tonight. And I would like to know - I know that I represent the school board and I know that Debbie Goldthorpe represented the school board. I would like to know if you got recommendations from the school board to replace Debbie and if you did, how many times, if you're not in agreement, can that - they be turned down? I guess that was my next question. Just how will that person be replaced? And if you don't agree, then what happens? If you keep saying you don't agree with that recommendation you know then what happens? Okay. And also, many of us have been on the board for a long time and I would like to state for the record that the board does a fabulous job. I am very impressed with the members and their commitment and their integrity and their ethics and their passion for North Canton. And that is how we have served. And I feel very badly. Am I allowed to give my opinion on this? I feel very badly that people who have given of their free time, because we are volunteers, but we care so much about our town – all of us except one was born and raised in North Canton. We're passionate about North Canton and we care only about the children and the future and we're proud to serve. And I just - I would so much appreciate a reason why they weren't renewed.

Mayor Rice: Sure. Inaudible... do that.

Mrs. VanVranken: I guess that's all I'll say, other than I guess my biggest problem, Mayor Rice, is that you've never been to a rec board meeting since I've served and I was adopted or I was asked to serve on this committee when Mayor Hines was mayor. So I've been on 10, 12 years, I'm not really sure. And so I'm wondering why they're being replaced when you've never been to a meeting to see how they act and how they represent the City of North Canton. That's my biggest concern. Thank you.

Mayor Rice: Okay ...inaudible... understand...

Mr. Snyder: Thank you very much. Does anyone else wish to speak to the council this evening? Mrs. Magel, go ahead.

Kathy Magel: Hi, I'm Kathy Magel. 1025 East Maple Street. I have some questions about Item No. 10, first reading 96-03, Ordinance, Rules & Claims. Ordinance No. 96-03 amending Section 1125.02 of Ordinance 50-03, Zoning Ordinance of the North Canton. And I want to thank Jon for clarifying, then you'd also have to change the Code of Ordinances, which is that green book, I understand that, by an addition of a definition of open space. Do you have a particular definition of open space that you're ...

Mr. Snyder: Mrs. Magel, I appreciate you bringing that -- I'll have to take the responsibility for this. As you know, as a past member of our body, on Thursday the agenda is set. The Clerk of the Council reminded me that this ordinance - as a matter of fact I believe that which you were pretty much the architect of, was still laying there in limbo in a tabled form. So I asked her to place it on the agenda to remove it from that situation. Consequent to that, I did speak to Mr. Foltz, who explained to me and that was just this evening, that he was not in a comfort zone with the new language that we talked about only last week, prior to a public hearing, which will arise, I believe, around the first or second week of March. So I did speak to the Chairman, Mr. Peters, and asked him if it would be alright that we did not address that this evening and left it alone. And my apologizes to you and my colleagues if I've caused any confusion, but that's what happened. I was trying to do a little housekeeping here not thinking that we weren't quite ready with the new one yet and it will mirror portions each. So Mr. Foltz will probably do that sometime within the next few weeks, along with the cooperation of Chairman Peters. I hope that answers your question.

Mrs. Magel: Yes. So there will be no action tonight.

Mr. Snyder: And again I apologize if I caused ...

Mr. Snyder: Yes. Pardon me...

Mrs. Magel: is that correct?

Mr. Foltz: Yea, that's correct.

Mrs. Magel: Chairman Peters, before it comes to council if you would give me a phone call and update me with specifics of the definition, whatever you're going to put it in and...

Mr. Peters: I sure will.

Mrs. Magel: if that's possible... Mr. Peters: Absolutely, yes.

Mrs. Magel: Thank you very much. Thank you.

Mr. Snyder: Thank you mam. Anyone else in the audience wishing to speak this evening? Yes sir. Chief, want to step forward and state your name and address.

Greg Juersivich: My name is Greg Juersivich. J reside at 303 Cole Avenue SW in North Canton. And I'm here to discuss ambulance billing. I guess what concerns me Jon, and other members of council. are a couple things. Number one, I believe that the North Canton EMS, North Canton Fire and North Canton Police Department are three safety services that I believe should be all funded out of the general fund rather than the way they are now. I have no complaints about any of those safety services. I do have a concern that it appears to me that I understand funding is a problem with reference to the EMS aspect, because costs keep going up because the city keeps getting older and older as far its constituents are concerned. But I believe it - from my prospective it's irresponsible to throw that financial responsibility back on the people that are least able to pay for it. I also think that using the excuse that they may have Medicare and they may have health insurance and therefore it's no big deal out of pocket expense for them, is one of the big reasons why health insurance is so high. Because everybody is so willing to pass the buck off onto insurance providers. But if council so decides to bill residents as well as nonresidents, then so be it. I do believe though that asking me to support a levy in addition to that is paramount to charging me double. I believe that the levies, at least from the best of my ability, from the number of decades that I was involved with EMS, those levies were never intended to provide for all capital expenses and things like that and they never did. I don't quite understand why EMS and fire has never been under the protection of or under the financial umbrella of general funding like the Police Department, but none the less it has not. Charging me though levy money on top of an ambulance call fee to me would be like going to Click's - and let me preface that by saying, I read in the paper that the levy would form a method of getting money for the privilege of having the service in the community. If you went to Click's and bought groceries and they said for the privilege of shopping here we're going to charge you an additional fee, would you pay it? I don't think so. I think that when you look at other communities, Jackson, Plain that surround us, they've been able to manage with more calls and charging outsiders and not charging their residents. I know Canton charges everybody, but they charge no levy. I just don't see it as being a fair way to handle the problem. But I don't come here with just the problem. I have what I believe to be a solution, which I believed I had for many many years and have suggested it on numerous occasions, but always fell deaf ears, and that is funding that would be set up so that levies would no longer be necessary. And I have specific reference to an income tax increase. And I have that method in mind because number one, levies never solve the problem, they just postpone it temporarily. Number two, the surrounding communities are - their income tax is two percent and so raising the income tax here from where it is now up to, but no more than two percent, would certainly be no major impact on the working people of this community because most of them already pay two percent. Because I also believe the majority of those people do not work in the City of North Canton, they reside here and work in areas where income taxes would be upward to two percent. So it wouldn't have any - it wouldn't have such a negative impact as it sounds on the surface. The thing that I also understand is it's political suicide for council to suggest an income tax increase. I've heard that story before from - you know like this is the wrong time to do that because it's an election year. This is wrong time to do it because it's not an election year. It's just never the right time to do it. But I also believe it is the right thing to do because it's the fairest thing to do to provide a city service and fund it in a way that you don't have to worry about continual funding in the future. Once again, if council decides that they're going to bill residents, fine. Just don't ask me to pay twice. It would be cheaper for me to live outside the city and use the ambulance by coming into the city than it would be to reside here and use the service. And I don't know that that's quite the - I just don't see it as fair and equitable, that's all.

Mr. Snyder: Chief Juersivich, if I may sir, your points are well taken. However, your point to the general fund and I'm sure you - as many years as you served honorably as the Chief of EMS service, know that that levy generates less than \$200,000.00. The general fund does about a million two hundred thousand towards the operation of the EMS services. However, and maybe we didn't make ourself quite clear, we've considered both options of the cost of transport to the citizens and nonresidents, the levy and reraising or we're putting a levy only and we're just moving it along and I don't know if we're due for a second reading tonight or not. But...

Mr. Juersivich: According to the agenda you are.

Mr. Snyder: Right. But before we reach the third reading portion we will probably do some studying on it. Two things - and you bring a very valid point, billing Medicare patients unfortunately does not relieve the fact of the co-pay or the initial out of pocket. We've received two different opinions and we intend to look at that. One is we can take, I think what they commonly call assignment, whatever the Medicare pays or whatever the insurance pays, forgiving the difference. And that portion, as the citizen paying the

levy takes care of that portion of it. That's one interpretation. However, another is that you cannot discriminate and say well we're going to take some and take not, but it is under consideration both - And I would welcome discussing with you sometime when you have a little time some of your input. As I say, your knowledge is invaluable to it and a...

Mr. Juersivich: Well you have to talk quick because at my age my knowledge dwindles. And I know that, I believe, that when we discussed charging nonresidents that it was made clear to me and again, it may the laws may have changed that you cannot - you could - you have to be equitable straight across the board ...

Mr. Snyder: Right.

Mr. Juersivich: and so you know you can't give somebody a break here and not give them a break there, you can't play with that as far as Medicare is concerned. And I know under the Medicare - assuming the person has Medicare, for example I would not. Okay, I'm not old enough yet, believe it or not. What the hell are you laughing about? Get his name. Paul ...

Mr. Pusateri: Sorry, sorry...

Mr. Juersivich: Better watch he's an attorney...

Mr. Snyder: Isn't that what they call an ambulance chaser?

Mr. Juersivich: Inaudible... the man just got here a few months ago for ...inaudible... Well anyhow, moving on, I think that - I really think that the safety services in the community are basic to the community's needs. And I understand that EMS is costly. I also understand - you know when you consider the number of elderly people we have in town, including myself for that matter, they're going to want, they're going to need the service you know and paying that co-pay repeatedly because you know you have repeat users. You know my father-in-law is from Canton is one of those you know and every time he goes by ambulance he pays the full tilt less you know whatever Medicaid - whatever his co-pay is. But it's still it's - even if it was fifty bucks or ninety bucks or whatever the case may be, if those people have a fixed income, that ninety bucks is a big deal. You know when I do something simple now, like I'm no longer under the health protection of the city and not being employed here anymore and it amazes me to find out a drug that I used to pay seven bucks for I now pay \$42.00 for it. You know and I'm thinking this isn't right. You know that - not that - not right from the standpoint that when I think of the number of senior citizens or elderly or whatever you want to call them, the gray power people, they're here in North Canton because it's safe, their needs are met and one of their needs is this potential for the ambulance. Nobody wants that ambulance in their driveway. You know they're the last thing they want to see. But they're awful damn happy when it shows up when they need it. And I think it's a service that they've come to want, to respect. And I think it's well worth the city's expense to pay for it. And maybe in a different corner - I mean given a choice between you know being alive and being on you know some other service, you know my street paved or whatever, I guess I go for alive and bumpy road. But a - and now I have both, I have a bumpy road and ...inaudible... But that's all I have to say...

Mr. Snyder: Chief, I appreciate it. And as I say ...

Mr. Juersivich: I'd like since you folks are really ... to me it seemed like it was a passing of the buck. It's like it costs a lot of money. What the hell we're going to do? We'll just turn it over and let these old folks insurance handle it and then we're going to tack on, if I read the paper correctly, you know we're going to increase the levy or at least maintain the levies for the privilege of having the service. And the service is pretty much established. I think it would be almost as politically suicidal to suggest it be abandoned.

The public use should be within the development not adjacent to, as this could mean the park could be in another development or even in another city or township. And then I put some examples for you to read on your own. Thank you.

But it would be nice to revisit that issue and see if there's some opportunity that we could - not to open us up to a lot of claims, but to at least have a little firmer understanding which would be somewhat conducive to what most people think is the situation. If the sewer runs constantly, there's no way to shut the sewer down. So I understand the logic on this and going to disagree and not approve it at this juncture.

But to do that the city had to declare itself in a state of economic distress I believe was the term and had to prove that the City of North Canton was worse off, as it was explained to me, economically than our surrounding neighbors. I evaluated that information, talked to both those gentlemen quite extensively about it. Quite honestly didn't agree with the criteria. Didn't think the city met that criteria. Expressed that to those gentlemen. And actually as a solution, because they have interest in this in other communities, actually an application has been filed I believe by the Development Board, to designate the entire county of Stark County in this distress, because really the county fits the criteria better because of the huge job losses throughout the county. So we're not going to miss out on that opportunity because we will be able to take advantage. The Hoover Company will be able to take advantage of those potential tax abatements

People asking me, I'd love to serve on the rec board, I'd love to serve on the rec board. The other most popular ones below that are probably the Planning Commission, Zoning Board of Appeals. I get a lot more requests than I can grant because there's not that many positions available. My belief in these boards is I try to give other people - more people in the community an opportunity to serve on these boards. It's no reflection - not meant to be a reflection of people not doing a good job or not being appreciated. The city is certainly grateful to the members that serve on all these boards and commissions. You know it's one of those situations as mayor you lose no matter which way you go. People that are on the boards want to stay on the board. I've got other people clamoring at me all the time, why can't I serve? And they say quite honestly you've got these other people that have maybe served 10, 15 years or more, why can't I get a chance? I can't get a chance because these other people keep serving. So it's a no win solution for me. I've got to make a pick. I chose to rotate people as much as possible, especially when there's a demand out there that people want to serve. I've got a couple boards and commissions you can't find anybody else to do it. So it's nothing other than just simply trying to give more people an opportunity to serve - because we have them in this community that want to serve. And everybody that serves on these boards in the past and in the future are very much appreciated. It's not a personal thing, it's not a negative thing. Mark Cerreta you mentioned this ... Mark Cerreta is a neighbor of mine, he's a good friend of mine. Yea, there's no animosity there, but as you know Mark and I talked about it and told him, Mark, I'm just trying rotate people you know rotate people out. He could very well come back...

Mr. Osborne: A conflict of interest?

Mayor Rice: It's not hard - I'll stand by the statement I put in writing.

Mr. Osborne: Inaudible...

Mayor Rice: And you had a copy of it and you know what it - you should know what it says, if not you can refer back to that document.

Mr. Osborne: It says a conflict of interest.

Mayor Rice: If not - I don't think that's what it says, but you can get it out. I don't think it says it in those terms, but you - you know I'll stand by what's in writing, not what you're repeating here tonight.

Mr. Osborne: As clearly as all those public hearings stated, the community is crying for some study and some flood relief. Why would you think there was any conflict of interest here when the community was begging through I think three public hearings? By not signing that you delayed action on this by the city for ten days. And I guess this contract was languished until I guess Mr. Held was forced to sign it on a pretense that you weren't available to sign it. So I don't understand where you were on that whole ... concern and you just ignored the needs of a sizable majority of the citizens who have ...inaudible... conditions. And as far as the tax abatement, again as I understand it, the county commissioner basically did ...inaudible... you since you wouldn't requisition and make this request for the increased tax abatements that come from the state ...inaudible... the entire city. And as I understand, you were approached first and you could of brought this to the city.

Mayor Rice: And I think I said that and said I disagree with the criteria that they were asking for ... and I don't believe the city met the criteria. That was my opinion. I relayed that...

Mr. Osborne: They wouldn't of approached you if the city didn't meet the criteria. The Stark Development Board is quite knowledgeable, they collect all these stats, they know... Mayor Rice: Okay.

Mr. Osborne: what is available and what's needed in all the economic - social economic information on the cities. So I don't think...

Mayor Rice: I'm not here to argue it, I'm answering the question. I know you're not going to accept or like my answer but I'm sorry I'm giving you the answer the best I can. That's - I'm explaining to you my decision. I think that's what you asked me to do. Moving on to the fourth item, I guess, which dealt with economic development.

Mr. Osborne: The secrecy ...

Mayor Rice: I will - tonight I'm pleased to announce that Mike Miller will be joining the City of North Canton as Economic Development Director effective February 1, 2004. Shortly after last year's election I began in earnest the process of bringing a full time director of economic development onboard. My research indicated that for North Canton to compete with our neighbors in brining new jobs and retaining jobs in the city, North Canton would need its own go to person, one who bring all the activity under one roof instead of fragmenting efforts to various elements of the community like we've talked before at TAP at the Chamber of Commerce, City Council, the administration, etc. I asked three members of the community to assist me in this process to narrow down the list of approximately 63 applicants. The committee asked that I hold their names in confidence until an applicant was chosen as to avoid being bombarded at home and at work by applicants trying to gain favor. After an initial screening of applications, we interviewed 12 people, from that we narrowed the list down ultimately to 4 and Mike Miller was a unanimous first choice of the committee. Mike recently served 12 years in the administration of Mayor Dick Watkins as public service director. And although he has no direct economic development experience, he had plenty of knowledge of the process. Mike helped Mayor Watkins on several development projects after the untimely death of their Economic Development Director, Bill McGeorge. I know some people have said that the requirements for this position should of mandated two years of direct experience leading an economic development team. Both I and the committee believe we followed the right course of action in allowing plenty of flexibility, otherwise somewhat of Mike Miller's abilities would of slipped through our hands and ended up benefitting some other community. The committee was comprised of three very action members in the community, representing unique aspects. First member was Dennny Flechtner, former city engineer, current chairman of our Planning Commission and a member of the Chamber's Economic Development Committee. Number three was Tom Besozzi, representing the voice of small businesses. He's a small business owner and also an owner of an international trading company from 1985 to 1992. This was not a secret process. Tax payers and residents were participants in this process and they can speak to the thoroughness and the professionalism of the process. I hope everyone in the city will welcome Mike Miller to our team and provide their full cooperation to keep North Canton a growing and prosperous community in the future.

He has told me he would accept the position - he's accepting the position and will begin February 1st with the city, it's as simple as that.

Mr. Osborne: You didn't answer my question. Do you think he was successful in the City of Canton in economic development?

Mayor Rice: Does somebody not hear ...inaudible...? I don't know how many different ways I can say it. We think he was the best candidate available for the position for which we were seeking - period.

Mr. Osborne: Mr. Mayor, Mr. Held was your hand picked choice two years ago. And in the last 90 days I think you've confirmed your happiness with him both for the Repository Editorial Board and at the question and answer period we had at the Civic Center. I've heard of no complaints on Mr. Held during your entire term as mayor. What is going on?

Mayor Rice: I think I just explained the situation.

At that meeting, which was mid-October you affirmed your happiness with him. Inaudible... you were satisfied - actually more than satisfied with his performance. This action just does not make sense.

Mr. Snyder: May I say something? So not to belay this, but unfortunately I would advise anybody if they would be inquiring as to the action of the Mayor the charter is very specific. Director of Administration serves at the pleasure of the mayor. He is employed at the will of the mayor. Whether you agree with it or not and whether us as council members agree with it or not, Mr. Held's personal relationship with us has nothing to do with the Mayor. Mrs. Kiesling: Yea, a couple things. I am concerned about the Director of Administration leaving us. I think it is our business and the main reason is we are responsible to the tax payers for the money that they give us. And Mr. Held was trained, we've spent a lot of money on Mr. Held. I think he's done a wonderful job these last two years. I know of no one who has complained of him - about him. And I almost feel as if it is a waste of money. We only have two year terms on the mayor you know if we really were going to change administrators every two years that would cost the city a lot of money. And in your campaign you did state you were going to keep David. So I'm very disappointed that you did not live up to that campaign promise as some people might say. I think it goes to how loyal you are to your employees who work at the whim of the mayor. How so many people have said tonight they work at your whim, at your beckon call. I'm not quite sure how you're going to attract new people to the city - why they would feel comfortable leaving a position to come work for you. I couldn't even imagine why they would do that because your term is up next November 30th. You may no longer be mayor and if you are mayor and you promised someone a job and what - what are we 30, 60 days into barely and you let him go and you will not explain to us why you let him go other than - I really don't know why you let him go other than - I really don't know why you let him go. And I don't think that that is a good enough explanation to the people - people's money that you are spending the way you spending. We spent a lot of money on David Held. My other comment is to the Economic Development Director, I think it's very obvious to everybody that I wanted to get onboard of the process from day one. The Mayor and I had a conversation probably three weeks after I was elected, knowing that I'd be chairman of Community and Economic Development, but I would love to get involved in the process, help do the research, do what it took to bring this person to the city and help us to the future. I was discouraged in that process, told that you didn't need any help - that was fine. When we got the information I met with ...inaudible... council members and we - all of us actually, except for Mr. Foltz, agreed that we wanted some changed in the duties, responsibilities, qualifications as you had mentioned earlier. And you and I had a conversation and you made it very clear that no way, we weren't allowed to change anything in that book. We either fund it or we don't fund it, but you were going to do what you wanted anyways. And that's putting it nicely actually. So I tried then - then it came back to everybody and I said you know what, we all agreed during the campaign this is something the city needed and I will be the first to say that. And you were elected as mayor and we decided as a team, the seven of us, that we were going to trust you and we were going to let you make that decision. But we trusted you with the intent that you were going to keep us involved and not shut us out. Well you shut us out. And I know you're saying you were being - you weren't being secretive, but I don't know of any other board, commission or anything in this city that the members of it are not known. I don't know one. And I don't know any single reason why the members of it should not be known. If they are willing to serve on that board then they are willing to answer to anybody in the city. They are helping you pick the person you would think would be best for the city. So I don't agree with the fact that they were afraid to get phone calls and people calling them to encourage them to hire them. I don't believe that. I think most people have too much integrity to do that in this world. So I'm very disturbed at that. And then again, you know I asked to get involved in the process. I thought I was going through the right channels and I had the President of Council call you. You do not return his phone call. Two laters - two days later I said, please send him a memo because I know he's interviewing people and I'd like to be able to get back to council and let them know how the process is going. That memo was given to you on a Friday, on Tuesday you called the President and said no, I want no council input this my role. On Wednesday I wrote you a memo stating I wanted to know why in writing that you absolutely refused to let any of us be involved. It made no sense to me. There's a council member on the Planning Commission, on the Zoning Board of Appeals, on the Park Department, we represent this entire city, the CRA Committee. We are on every board there is just to serve as liaisons, which I think has been said several times in the paper. That is our job. And you wouldn't allow me to do my job as Chairman of the Community and Economic Development. And that very much bothers me, because you are spending these people's money that I am responsible for also. So I send you memo and asked you to give me in writing why you will not allow me in the process. Well that was last Wednesday and I don't have a reason in writing. Then I sent you another memo, which the Law Director and I have talked about, stating Section 3.03 of the Charter, which you and I had a conversation about. And the Law Director is going to give me a formal opinion, but in my eyes you are wrong, we do have more power on Section 3.03 than you assumed. I believe that's why you hired your man today. And here we are not knowing what we should do because and I think it's obvious, five of us at least felt as if we were going to repeal the legislation because we weren't happy with the process. That open government was not fulfilled in this area, not even close as far as I'm concerned. I trusted you and I knew I shouldn't of but I did. And then I got the support of five people to repeal the legislation. And now it may be a little bit harder to do now that you've hired this person, but I'm still onboard to repeal the legislation if I can get four members to do that and start from scratch with a board that represents the cross section of this community. Denny Flechtner is on the CRA Board, the Planning Commission, he has four contracts currently with the City of North Canton in - with CT who he works for. He has a conflict of interest. Tom Besozzi, he was on your campaign to be reelect committee. I think they represent - they are not a fair representation of the cross section of this community. I think you picked people who you don't even know to come and help you. Or people who may have experience in the field like Daryl Revoldt. You know what, Daryl Revoldt would of been your best pick. And none of us would of said a word because we would of thought dang, he actually stood back, put his differences aside and said you know what, Daryl works for the Governor in economic development, he may have a lot of ideas that may help this city.
