Mr. Foltz: The appointment of Director of Finance Julie Herr.

Mrs. Hines: The North Canton Charter states: "A Director of Finance appointed by Council for term of two (2) years shall be head of the Finance Department and shall be fiscal officer of the municipality." Julie Herr came to North Canton in 2001. She has a Bachelor of Science Degree in Accounting. She's been a Certified Public Accountant since 1994. She was Assistant Director of Finance for the City of Barberton for seven (7) years prior to coming here, and she has received the Government Financial Officers Certificate of Achievement for Excellence in Financial Reporting every year since she's been here. So, at this time, I've spoken with all members of Council; and, therefore, I am recommending that Julie A. Herr be reappointed as Director of Finance.

Mrs. Hines moved and Mr. DeOrio seconded to approve the reappointment of Julie A. Herr as Director of Finance for a two (2) year term. All members present voting: Yes: Magel, Repace, Snyder, DeOrio, Foltz, Hines, Lane

Mr. Foltz: Next on the agenda is Council appointment to Community Investment Corporation Board.

Mrs. Hines: Okay, then we - this has been called the Community Improvement Corporation and the Community Investment Corporation, and we're going to go with the bylaws that says the "Community Improvement Corporation." Last year Mayor Tom Rice and then-City Administrator Mike Miller, with the help of others, worked on membership and funding issues for the Community Improvement Corporation. Last November, North Canton voters passed Issue 31 which funded the CIC with \$1.5 million dollars, giving \$100,000.00 to the CIC each year for fifteen (15) years. This fund would be used - or will be used to encourage economic development in our City. Membership was expanded from four (4) to eight (8) members for a balance of power. These members are the current Mayor of North Canton, current Director of Administration, the Finance Director, the Law Director, the current Council Economic Development Committee Chairperson, the current Council President and two (2) appointees. The Mayor has made his appointee, and now, having thought, Council has an appointee, and at this time, the thought is that the former Mayor, Tom Rice, is an initiator of the present CIC. He's knowledgeable of the entire history and workings of the CIC, and having offered his abilities to the future of North Canton where needed, I recommend Tom Rice as the City's appointment to the CIC.

Mr. Foltz: Excuse me. Sorry for the mispronunciation. You wanted to come up and address us tonight, first, then we'll open up to the rest of the audience.

Mr. Fothergill: Thank you. My name is Bob Fothergill. I'm the community organizer for Stark and Carroll County for an organization called "Voices & Choices." It's an

initiative of the fund for our economic future. Just to give you a little background. Voices & Choices is your opportunity to help shape the future of northeast Ohio. Thousands of residents across the region are working together to decide what we must do to make northeast Ohio great again, to create jobs and improve quality of life for all. The communities of northeast Ohio are competing against each other against other regions across the country and around the world for better jobs and opportunities. In order to compete, northeast Ohio needs to pull its resources and work together as a team. The fifteen (15) counties of northeast Ohio are home to more than 4 million people, and they can reach a larger population than 23 states. Our regional economy is greater than many small countries and employs one-third (1/3) of all workers in the state of Ohio. Together, thinking and acting as a region, northeast Ohio can be a collective force to be reckoned with in the global economy. We need to come together, create a solid game plan so that we can assure better future for all of our residents. Voices & Choices has, over the last few months, had 11,000 political community and business leaders meet at - throughout, across northeast Ohio in leadership workshops. We have interviewed around 3,000 citizens on the assets and challenges of northeast Ohio. And on November 12, 2005, at the University of Akron, we had a town hall meeting - an all-day affair that had 750 people in attendance and talked about the assets and challenges of northeast Ohio, and how we can improve this region in creating jobs. What we're asking now is we're bringing it down to the communities. We're having a thing called "Community Conversations." We're asking the community leaders, political leaders and the citizens of North Canton to become involved, hold a Community Conversation with an organization, where there's individuals in your own home, so we can talk about the assets, challenges that face northeast Ohio and how we can overcome then and compete as a region to better our economy in the 21st century. can be reached at 330-833-5657. We also have a website: www.voiceschoices.org, and you can contact us. We do everything to help you set up to have the Community Conversation. We would bring a facilitator if you need one, or you can do it as - on your own. It can be as small as five or six people or as large as 100 or 200 people. And that's it.

Mr. Foltz: Any comments from Council?

Mr. Lane: What's your — without looking through all this — I am somewhat familiar with the program, but I'm not sure. How long are you going to be at this? Is this something that ends at the end of 2006, or is this something —

Mr. Fothergill: We're looking at Voices & Choices, itself, probably ending around November of this year. We're going to plan on having, of course, these Community Conversations and also another regional town meeting and also leadership workshops. Then, the Fund for Economic Future is still here, and they've come in at \$30,000,000.00 to follow through with this.

Mr. Lane: So, you would want to hear from people here before November.

Mr. Fothergill: Yes. We're planning on having Community Conversations starting in February, going to May. And then we'll then move into more of the leadership workshops and the town hall meeting and bring from that some challenges. We also want to know what solutions there are out there. And that's what we're wanting to know from the citizens of North Canton, Stark and Carroll Counties.

Mr. Lane: Thanks.

Mr. Foltz: Thank you very much. I appreciate it. Anyone else who wants to address Council tonight, please state your name and address.

Mr. Fano: Dick Fano, 1382 Elmwood, S.W., North Canton. I've been coming to Council meetings for five (5) years now. I sit back there in that chair, and I listen to everything that goes on up here. And a lot of it I can take, and some of it I can't. Last week you threw around something that bothered me. First of all, I don't think the City has the finances to go for the Crowder property. And I just wanted you to know, as my opinion, as a businessman in North Canton, I don't think that the City should go for it. We don't need any more parks. We have eight (8) in this town

> now. And I know Doug is a park man, but I just don't - I just don't feel - Councilman DeOrio over there says we need to start thinking smaller. And I agree with him. And if there's gonna be any money appropriated in this town, then I think that the next move - you're gonna keep hearing from me until I die - is going to be Seventh Street and North Main. And I figured out that if take that yellow line - that double yellow line from the square and go north, the west side of it is Foltz Territory, and the right side is Magel's Territory. So, you two are gonna be in my sights until that gets done. So, that's it. I don't have anything else to say.

Mr. Foltz: Appreciate your comments.

Mr. Fano: All right.

Mr. Foltz: Anyone else who wants to address Council tonight?

Mr. Silverthorn: I've been here before. City Council, Administration, Mayor Held, my name is Tom Silverthorn. I live at 1283 Lipton Avenue, S.W. Just to continue an observation I brought up here about a month or so ago. Pardon me if I get winded. I just got over pneumonia. But Jon Snyder knows exactly what I'm talking about. I'm just - so, you can take a nap if you want, Jon. I've been living in North Canton - working in North Canton since 1986 at the Timken Research facility. I moved to North Canton in '94, because the neighborhood that we lived in was deteriorating rather rapidly. The time we moved in, we probably had the worst house on the block. Twenty years later, when I moved to North Canton, I had the nicest house on the block. So, what's wrong with this picture? And I could have moved to Louisville. I looked at Hartville, Canton South, but was working up at the research facility. It made sense to come this way. And an issue is, as Jon knows, 1313 Lipton – I have a picture of the property of my neighborhood taken, excuse me, which I have included. And I checked, Jon. It hadn't been two (2) years since I started complaining about these people. It was four (4) years this month that these people moved in and started causing the havoc and the hell they have. Pardon my French, but the house is a dump. The last time I saw their trash put out was at least five (5) weeks ago, so God only knows where their trash is other than in the back yard and the side of the house, which I hope my pictures will show fairly well. It's, it's been everything - trash and cars in the front yard, extremely loud music, brawls in the street. The police had to be called. Complaints more than once of trash laying out in front -- trash cans laying out front. The pictures will do a thousand -you know, the word deal, which I'm - I'll cut it short, because I do want to pass these around. But this is something I mentioned to Jon, too, is - I've heard this more than once since I've lived in North Canton, and that is - I hate to say it, you know, but we live in the slums of North Canton. And the only thing that reinforced that is, is the poor people over on Bonnett with that water thing. That was a disgrace to this City for them to have to go that long with that much crap, when I only live about two (2) blocks away, and my water's fine. You know, what's wrong with this picture? But enough of that, but I would like to see something done. These people – Jon said they send them letters, registered letters, try to hold them accountable for their condition of their property. They don't give a damn about a registered letter. They don't care about their property. What do they care about a letter? It goes in the circular file as soon as their done reading it - if they read it. So, I'm hoping that Jon mentioned to get to Mayor's Court and start fining these people. Four years now I've complained. I complained the first time they did this four years ago, and we're still fighting the issue. Fine them. Do something. Right now we're doing nothing. Absolutely nothing. Again, the ordinance with no teeth. I mean, if you lived on my street, you would be appalled, to say the least. But, Doug, I'll cut it short. My friend and neighbor, Chris Feller, would like to speak on another issue on our block which is kind of near and dear to us. If you would, I'll pass the -I'll get these pictures to Doug Lane, and at your convenience, if you would. Okay. Thank you very much.

Mr. Foltz: Okay. Please do, sir. Thank you.

Mr. Feller: Chris Feller, 1291 Lipton. I certainly don't want to belabor a point that Tom just recently talked about, but being a homeowner in North Canton now for approximately a year, I was in the same boat Tom was 11 years ago. I could have lived in Hartville. I could have lived in Louisville. My options were certainly open. But I wanted to move to North Canton - first and foremost, it's one of the top 100

communities in the nation. If you drove down my street and looked at 1313 Lipton, there is no way in the world that you would think that. People like myself and Tom and a couple of our surrounding neighbors - we work day and night to keep our properties looking good, well maintained. We mow our yards, we follow our ordinances, and it's not paying off for us. The continual home improvements we do are not paying off. When somebody comes to my house, the first thing they say to me is, "Did you see the house two doors down? What are the cars in the front yard for?" It's a disgrace, and it's an embarrassment. And I certainly don't think it's something as a North Canton resident we need to put up with here. As Tom had previously said, we've got cars in the yard. We've got trash in the yard. We've got loud music all hours of the night. I've talked to Jon numerous times. We've had fights out there in the middle of the night. We've got people speeding up and down the road just going to that house. Just the general appearance, alone, is enough to upset any of the surrounding homeowners. And I had previously asked what an action plan would need – what we would need in terms of an action plan to get this corrected. And I guess my first question would be, has anything been established at this point in an effort to clean up this property short of the registered letters? And, secondly, directly across from that - I don't know if anybody's been in the neighborhood. We've got a new construction home on the corner of Lipton and Maplecrest. I think we've also brought that to Jon's attention. After looking at the zoning on line today through North Canton, short of getting out a tape measure, they are very close to not meeting zoning regulations for a corner lot. appearance is poor. This home has been under construction for six (6) plus months now. Our streets are covered in mud because they've done no control with the grades or water runoff. Basically, it took interaction from the City to get the excavated areas cleaned up. We still continually have construction debris in the area. It's just a general nuisance to the neighborhood. Basically, those are our number one concerns in the neighborhood right now. I find it hard to believe that nobody else living around myself or Tom has come up and made the same accusations. You know, we've got the typical problems that our end of town does. We've got terrible potholes on the south end of our road. We certainly have our fair share of drainage problems not having curbs in the neighborhoods on all streets. But I think our biggest concern, and the one we want to touch most on right now, is 1313 Lipton. Thank you.

Mr. Foltz: Okay. Thank you.

Mr. Snyder: President Foltz, if I may address so that everyone knows where we're at in the situation. And I do appreciate both of those gentlemen coming up and, again, expressing their views. 1313 is a problem. It's an absentee ownership. The problems that we have with that property I addressed to the Council last week. And hence to that, I've worked with Mayor Held and Superintendent of Permits Hemminger to try to get a little more comprehensive enforcement action. It will take some time, because that is a zoning issue. However, what happens is that the present mechanism is a registered letter to the home. And, unfortunately, when it's a rented property, that person just pitches the letter. That is a problem. It's borderline almost to the point where it's going to become a public nuisance, as I had once before a little bit further north of you on Church Avenue. You know, and it does bother me, and I feel badly when people say the "slum." Here's what's happened to some of the areas of the fourth ward so people understand. I am not a proponent of rental property and never have been. The City has gone at one time since I've been on Council - from just a little over thirteen percent (13%) rental properties - almost at one time we were at twenty-three percent (23%) rental properties. Rental properties are a problem for the City, the enforcement of our zoning, the police, the fire, our public utilities - everything, because, generally, it's a demand on that, so we try to limit that. And what's happened in that particular section of the City, it is a little older section. Some of the homes are big. They buy them. They split them or duplex them, and they rent them for very large sums of money. And they really don't care about the ownership. The problem will have to come where we change our zoning, where we actually have an enforcement tool in our zoning by either an enforcement officer by view of a nuisance officer or Mr. Hemminger, himself, issuing a citation to the Mayor's Court. People only understand one thing. When they pay for something, they appreciate it. And if they're not penalized financially, they will not appreciate it. And relative to that

property on the corner, Mr. Labriola, from the Department of Inspection, was there. I was there. He talked to that builder. We measured. He's right in with it. He's right at - you're right. He's right on the line. He did consent, and I'm hoping he keeps his word, to build some type of porch on it to dress it up. But it does - it isn't really aesthetically what people want in that neighborhood. (Inaudible) Hopefully, right. I have to be careful what I say. I don't want to - but he is - he is working on trying to dress it up a little bit. I know it's a very slow process. I apologize to you, but it's going to be until we actually go through the process of changing the mechanism where we enforce our zoning laws. We have isolated pockets throughout the whole City. Unfortunately, in the fourth ward, those four or five streets - and I have another one - one street over from you where I have about seven families living in a house. That one hasn't surfaced, but it was just brought to my attention. They're in the basement; they're in the attic; they're all over the place. So, I mean, I'm – you know, pretty soon, you know, it's going to be like, you know, spend my day over there with a police dog or something. But we will, I promise you. It's gonna take a little time, though. It won't happen in one or two months, but we'll do something. I'll get with Mr. Pusateri on this one, because once it borderlines becoming a public nuisance, it goes into the next phase of zoning. And we'll see what we can do. And I promise, again, as I've talked to you, we'll - I know it's slow. But it moves very slow. But we are - I spoke to Mrs. Magel this week about it. She's offered her help. She was the original architect of that zoning. She, at that time, wanted to put more enforcement, and we as a Council backed off, because we felt we did not want to be the heavy. And that was a mistake we made, and I will shoulder part of that blame. But we will, as a Council, eventually in the next few months, change our zoning that we're able to enforce the laws that we have. Because right now, really, they are – I won't they're a joke. But they are a very slow process. Its' - and then, the problem is, once they conform, the whole process stops. And then they can go the next day and start all over again, and the process begins. And it's a very arduous process. But I promise you we'll - you know, you deserve more than that. It's a beautiful neighborhood. It's well treed, and it's a nice neighborhood, and you don't deserve - no one - everybody deserves peace and tranquility no matter where you're at. And I promise you we'll - I have the support of all my Council members, which I appreciate. And they're all - and Mr. DeOrio asked me today how am I doing on it. He's very concerned about it, as the other members are. And we will address this and get it done for you. But, again, I thank you. Please keep coming back. Keep us informed, because government moves slow; people move quickly. But thank you.

Mr. Foltz: Member Snyder, thank you. You chair Ordinance, Rules & Claims. Why don't we, maybe, start the process next month and just to have some discussion to see what ideas we can bring forward. I mean, talk to Gene Hemminger and the administration, too, and our Law Director and put – as we just discussed, more teeth into our ordinances –

Mr. Foltz: So, you know, the neighborhoods know that we have people that have great housing here, and we're not going to allow substandard housing – whoever owns it.

Mr. Snyder: I appreciate your support, sir.

Mr. Foltz: So, let's start that process. At least we can have the end justify the means here.

Mr. Pusateri: Are those pictures copies, or can we keep those, or...

Mr. Silverthorn: No. You can have them.

Mr. Foltz: Okay.

Mrs. Magel: I would just like to say — actually, Member Snyder and I have been talking about this. And I was part of the zoning book, and I did have a component in it that it should have been stricter. I wanted to put some teeth in it, but, you know, at

the time, that just wasn't the Council's mood. But I thank you for coming up. I think – have I met you approximately – is this about your third time up?

Mrs. Magel: Okay. Well, this is what it takes. I appreciate your coming up. And there is a problem here, and Jon, let's work. We'll get something going. Maybe I'll give you a call – work some verbiage out and we'll get this started.

Mr. Silverthorn: Thank you; appreciate it.

Mrs. Magel: Let's hope that it goes faster than open space.

Mr. Silverthorn: I have one more thing to suggest - I talked to Jon about is - and it's, again, it's the appearance of the house. Its' people that have parked in their front yards. That's been an issue with this house. It's been an issue down on Elmwood. These two places Elmwood – Orchard Hill – one of those. Ten years, and I still can't remember the streets, but, and we mentioned, too, the comment that these people have put their cars in the front yard for sale. Well, that's the idea - I don't care whether it's for sale or not it's the front yard. In a parking area, am I right, the ordinance says a designated parking area. When I moved up here, I needed space for my van. I got a big old hog Chevy van. I had it dozed, landscape timber put in, you know, gravel - the whole nine yards. And I have a nice place to put it. It doesn't look like I just fell off the turnip truck, you know, when I moved up here. Why can't these people do that? Now they - some people do it constantly. It's a constant thing. And some people put a for sale sign on it. And then one guy down Applegrove...I swear to God, he's got a used car lot behind him. Every day you go past, there's a car out front. He put them - he sold one yesterday, because I didn't see it. But it's - I don't know, maybe I'm overly picky, but after seeing the neighborhood I lived in go to crap, I'm not about to move again. I'd like to stay in this neighborhood, you know, really. Thank you.

Mr. Foltz. All right. Thank you, sir. Anyone else want to address Council?

Mr. Osborne: My name is Chuck Osborne, 307 Fairview Street, S.E., North Canton, Ohio. I hadn't intended to speak tonight. We all knew it was a problem three years ago, whether it was the fact that I was Chairman of Finance, (Misspoke -- Chairman of Ordinance, Rules & Claims), and we didn't want to see any progress under Mr. Osborne, I don't know. But it seems that three years now, suddenly people realize, oh, it's coming back to bite ya in the butt. So, I do hope you do, this time around, give Mr. Hemminger, or whoever in the future turns out to be our Superintendent of Permits & Inspection, some authority to make our ordinances work for the public. Thank you.
