#### 7. Recognition of Visitors

Mr. Foltz: Next is recognition of visitors. Anyone would like to come up and address Council, also the Administration please forward and state your name and address.

Mr. Stathakaros: My name's Bill Stathakaros and I live at 1575 Yorkshire Trace S.E. in Monticello. I've lived there for 5 years, bought a home there in September of '02. It was a Parade house and there was one of the homes in the Parade was never finished because the builder went, I don't know, he went bankrupt. The house has been through numerous foreclosures. The house has never been completed. It's been there for 5 years. There's animals that live in the basement. I can't see how they would ever finish the house. I've called several times to different, you know, departments in North Canton. The gentleman I'm with, Bill Stamaton, he lives next door to the house. We've been told, you know, I basically had asked for them to demolish the house, and I've been told that they can't demolish the house because it's been in foreclosures, and that's not true, because I was told in Canton City by several officers down there that no matter if the house is in foreclosure, or if it's - whatever state it's in, if it's a health hazard, it can be demolished. So, I mean, I made pictures of the house. A gentleman told me here tonight that somebody went to it and said that there was no animals living in it, which is not true. There are animals living in it. Mr. Stamaton has two small children, if one of those animals bites one of those kids; I don't think anybody here at Council would be the one that'd want to tell him where they'd have to go get rabies shots. So I'm here willing to even help pay for them to knock it down, so it won't cost North Canton nothing. You know, we're losing this tax base over here, all our houses, the - the - the property tax that we pay are anywhere from 4 to \$5500 a year or more. Up to 7-\$8,000 a year. You know, I went to go get a business loan, had to put my house up, I got 3 appraisals. Every time the under rater - underwriter wanted to lower the appraisal on my house because of that house. So, you know, I'm not the kind of guy that wants to you know, come here and you know, give you a sob story but I've had enough. So either Council's going to do something or we're going to have to try to figure a different way to you know, with - I don't know, through the media or whoever we got to do it, but this house has been there for 5 years. So...

Mr. Foltz: Sir, if you could pass that along.

Mr. Stathakaros: I made a picture of this so you guys can all look at it and thank God, I'm only four doors down but Mr. Stamaton has to open up his garage door every day...

Mr. Lane: Inaudible...

Mr. Stathakaros: and look at that house. And the other thing is the house should've never been approved to be built the way it was, because the plot on it, they've got it built like in the oddest spot on the lot. It ruined the house next to them. Scott McCue had tried to sell that house for 5 years. He had it priced at 540, ended up selling it for 400,000 bucks. Now, I don't know about you guys but our houses are our biggest investments. You know, and since my house is gone down in value, I got a half a million dollar house that's not worth a half a million dollars anymore because of this. Maybe everybody in our neighborhood should call up Gary Ziegler and have him reappraise our houses so, you know, everybody can lose more tax base, I mean, you know. Something has to be done about this, so.

Mr. Foltz: Sir, I-I drove about — by this — before the meeting and it's a shame it's — as — as we all know you live in a gorgeous neighborhood, and we're very proud to have Monticello as part of the city and as you mentioned...

Mrs. Magel: Thank you.

Mr. Foltz: there's 4 or 500, \$600,000 houses in that allotment and...

Mr. Stathakaros: I couldn't get an appraise, I couldn't get...

Mr. Foltz: It's – It's a shame when you – when you see it, I mean it's – obviously it's mostly finished from the outside, the landscaping needs taken care of, I think the garage doors are boarded up and the front side panels on the main door are, just a quick – I didn't get out and walk around...

Mr. Stamaton: I'm Bill Stamaton S-T-A-M-A-T-O-N; I live next door to the house. You know, we've looked at it for 5 years I – you know, I personally know there's animals running in and out of there 'cause we – we – my kids name them and we – we see them every day. And I – I've been in the house, I know there's pockets of dark places that look like mold, I mean, I just think it's – it's disgusting at this point and – and that, you know, 5 years, and it's going to go through another hot summer, so whatever is in there now is going to grow by the end of the summer. How long does it have to be before we can do something? I mean, where's the – who do we go to or what do I do as a – as a – as a neighbor? What – what's the cut off point where we finally say hey, we can do this? That's – I guess that's all I'm looking for.

Mr. Foltz: Alright, we'll - we'll try to answer those questions. Member Lane, you want to....

Mr. Lane: Yeah, I'm not going to go through the whole history of it, 'cause believe it or not...

Mr. Foltz: Sure.

Mr. Lane: I've got about four things that I've got a file about this thick...

Mr. Foltz: Okay.

Mr. Lane: on and this is one of them I inherited when I took office in December of '03. And we thought we had a glimmer of hope when - when the lady bought it from the original construction company and even at that time though, Mr. Caticchio from the Monticello Association and I - I've got the documents somewhere - had - had a sit down with then Law Director Pusateri and said the math doesn't work on this. It's not going to happen. But, because of laws and everything else, they had to let her try. Obviously, she got to a certain point and just gave up and as of April the 8th, I believe it is, that it went into foreclosure, there's every bank in the United States has got a lien on her for...this property and many, many others. I talked to Mr. - I mean just the most recently, I talked to Mr. Stamaton back in March, we looked into some things, had zoning look at it again and when I talked with Gene's office in May, after talking with Mr. Stathakaros, they said that they had turned it over to the Law Department to look into this and Randy I know visited the property and as I - I relayed that information to Mr. Stathakaros that he didn't find any animals in the basement but that there was some water damage and some other things, so, I think I'll defer to - to Randy to at least bring people up to date maybe on what some of the action is we can do, if there is anything. I'm not a lawyer but I've been told foreclosure kind of freezes the clock on things, but I might be wrong on that.

Mr. McFarren: Well, the first thing is, this house – this house is in foreclosure. When we looked at it earlier this year, there were very good indications from the court records that the property owner was in trouble. Since – since that time, the house is now in foreclosure, that's the bad news. The good news is at least in a foreclosure eventually, this thing will be resolved, it'll end up with a new owner, it'll be sold probably at sheriff's sale and somebody will

most likely complete that house and this headache will end for you. I've been in the house, I've been - I didn't go down in the basement to see - to see who was living there. But I was -I was in the house, went around and looked at everything. There is actually some finish coat paint started in there. The house is in - is in the final stages of finish, it's waiting cabinets, baseboards, final paint, trim selections, floor coverings, things of this nature. Now I will grant you, that the house shows some very obvious signs of water damage. I'm not a contractor, I'm not a builder, I'm not an engineer. I know what I saw, and the house is in final trim stages. You pour some concrete for a driveway, you put some doors on that house, you fix the sidelights where it's been knocked out and plant a front yard, and it's going to look like most of the other houses in the neighborhood. So it's close. The long and the short of it comes down to this, okay, government operates under a set of laws and a set of rules and if we came into your house and said your house was substandard and we're going to bulldoze it, you would be immensely upset with us. That's where this house - this...house belongs to somebody. It's a valuable piece of property, and I guarantee about the time we bulldoze it, this house becomes about a \$3 million house, and it becomes a \$5 million lawsuit and it was just perfect and all it needed was a coat of paint and life would be wonderful. So the long and the short of it comes down to it will be resolved over a period of time. And as of this point in time, I don't think there's a whole lot we can do with it.

Mr. Lane: Is there anything from the health standards if – if you didn't go in the basement, is it possible we could ask the Stark County Department to at least give it a once over and see what their feelings are on it?

Mr. McFarren: Well, you could always get somebody else to take a look at it from a different angle. I'm looking at it from is this thing a - a safety hazard. Now I will grant you, you could probably get yourself hurt there if you're not careful what you're doing because they have put oriented strand board down like over the porches and that stuff deteriorates when it's wet, and that house has been wet, okay, so if you're up there walking around on one of those porch areas where they haven't poured the concrete, they haven't poured the concrete in the garage, they haven't poured the concrete in the basement, they haven't poured the driveways. You could get yourself hurt. But you can get your...self hurt almost anyplace when you're someplace that you shouldn't be. As far as the house goes, when I was there, I closed every window I could close, I locked them. I locked the doors. I can tell you that somebody has forced their way into that house, there's nothing that you can do to stop that. We call that burglary if they steal something, if somebody wants in your house and they bring a big enough screwdriver, pry bar, pipe wrench, they're going to get in. That's what happened at that house. I was surprised, there's very little vandalism, very little graffiti, again it's in the finished stages. Whether it'll ever be finished or whether it'll be torn down, that's an engineering call but it's certainly not for me.

Mr. Foltz: And the other question is there anything that the owner of the subdivision can do, at least with the yard? I know, I know it'd fall under our requirements as far as height of nuisance grass and so forth. It's probably similar to the empty lots out there. Maybe a little higher in growth, but just the backyard's a mess too, with piles that've been there for probably for 3 of 4 years, maybe not as long as 3 or 4 years, but as long as there's been a — a finish attempt on the house. Is there anything that can be done with just...

Mr. McFarren: Well, our...

Mr. Foltz: mowing the lot or getting that straight, at least get some grass growing there to be somewhat more presentable if we can't touch the house?

Mr. McFarren: We're spending, as far as mowing it, okay, our new grass ordinance goes into effect sometime here the beginning of July, probably the second week. On that basis, if it's in violation we could go in and mow it, access it to the – to the tax duplicate, we can do that. You go in there and start spending taxpayer's money to landscape and grow a yard and stuff like that and you're going to get yourself in world – world of problems.

Mr. Foltz: That's why I brought up the – the owner of the subdivision. I didn't know if there was something they could do...

Mr. McFarren: There's probably a slew of...

Mr. Foltz: whether that would be legal or not, I don't know.

Mr. McFarren: There's probably a siew of homeowners regulations out there, that I don't know. You know, there's probably a ton of violations that way, but that's between the Homeowners Association and the property owner.

Mr. Foltz: Again...inaudible...we've been on this topic and we're asking you questions...

Mr. Stamaton: Yeah, I don't want to waste anymore of your time.

Mr. Foltz: Sure.

Mr. Stamaton: I'm not an attorney, you know. I've talked to several people, and I understand you know, the city doesn't want to knock something down and get sued, but to — to use the analogy, that I wouldn't want somebody to come in my house and comparing it to that house, isn't even close. I mean, that...in fact, that ain't even in the same ballpark, okay? Number one, that house is not in the final stage of finish work. I've built three houses. And when they finish that house, they're going to have to disclose all that stuff, and I don't know anybody that's going to buy that, but that's not even the issue. You know, I understand you guys don't want to get sued, I appreciate the time that you've given me, thank you very much.

Mr. Foltz: Alright, thank you sir.

Mr. Lane: Can – can I? Earle, I know you were over there at one time too, is it possible that the city could at least ask the health department to look at it? Is that possible, I mean...

Mr Wise: Yeah.

Mr. Lane: Could you make a call to Stark County Health?

Mr. Wise: Sure.

Mr. Lane: Thank you.

Mr. Snyder: You know, you should – the fire code is much more broad, and has much more enforcement than our zoning or health. The state fire – and you know we have Prevention Bureau, you should send the Fire Prevention Bureau because their powers are much broader than the Health Department and our own city enforcement under state law. If there's a fire, that's

Mr. DeOrio: Well the – but it still comes down to this though guys, is that, who's going to be responsible to do it? So if you go over there, and you give them fire citations and you give them this citation and that citation, it's just going to end up getting added to the tax duplicate. The homeowner is in – is in foreclosure. She's – they don't have any money, otherwise they wouldn't be in foreclosure. And until it's foreclosed upon, until the banks take control of it, it's going to be in this state of limbo. I think once the banks take control of it, then they're going to have an interest in, you know, preserving that property and trying to preserve their profit. You know, when they turn around and they sell that property, they're going to have to pay all those liens that are on there, so I think once the bank gets control of it, you – you're going to find that you – you'll have a property owner that wants to improve it in order to get the maximum value for it.

Mr. Foltz: Oh absolutely.

Mr. Lane: Yes.

Mr. Foltz: Jon, I remember we had one in your - your...

Mr. Snyder: Yeah, Church

Mr. Lane: Church.

Mr. Foltz: It's still probably - maybe a problem, I don't know...

Mr. Snyder: No, fortunately, he met us on the Courthouse steps there and did - he did his job

but...

Mr. Foltz: Is that right?

Mr. Snyder: That did in fact have a lot of animals in it.

Mr. Foltz: Yeah, right, we had a whole episode down there.

Mr. Snyder: Yeah, that - that was a little different ball game that we actually...

Mr. Foltz: Right, but even...perimeter-wise that was a nice house in a nice neighborhood.

Mr. Snyder: Oh, magnificent house.

Mr. Foltz: What's difficult is to say we're going to tear down something that's probably got 300 - \$400,000 of equity in it. 'Cause somewhere along the line, there's some misjudgments made and they couldn't pay their bills.

Mr. Lane: And again, that might be where we have to hang our hats, so Earle, if you could at least ask Stark Health to take a look at it and at least give us a reading on that. I think Gene did a few years back but it – it hasn't been recent, I know that.

Mr. Wise: Will do.

Mr. Foltz: And Randy, you can't give us a timeline on foreclosure, right? There's no - is there anything that you know of?

Mr. McFarren: The - the bad news is on foreclosures is look in the — look in the *Repository* on Thursday. We've been running 20 to a page and there — and they run like 10 pages and you look around and you know, every 4<sup>th</sup> sign that you see that's a "For Sale" sign that's for sale by either the bank or an entity that's owned by the bank that has taken the property back so they could get it off the - the bank's books. There's just — there's just a glut of stuff and I mean we're just we're not bogged down like Cleveland. Cleveland is so bad, they're filing foreclosures in Federal Court. But we've got so many of them that things are running slow. You could easily, and I know these people would just go up like a rocket, and you could easily be a year, year and a half, easily. And it's not that anybody's making anything difficult, it's just jumping through all the hoops and - and literally standing in line until that case moves up to the point where — where it's turned over to the sheriff and then the sheriff is going to sell that. There - somewhere there's a contractor who really knows his stuff and he's going to look at that house and he's going to figure out what he can bid and still make a buck on it, and — and it's a nice house. It's a nice layout. It's got — it's got a lot of problems but it's not for me to determine if they're structural.

Mr. Foltz: Okay, any other comments? I guess we'll...

Mr. Lane: I am happy he brought the pictures so at least everybody that hasn't...

Mr. Foltz: Yeah, everyone can see it.

Mr. Lane: been by has a chance to see it so ...

Mr. Foltz: We don't live next to it, but you know, it's a nice looking house that - outside-wise. It's just a- it's a shame that these things are unfortunate that have to happen to our neighborhoods, so.

Mr. Lane: I think what complicates it as well is the fact that she's got 4 or 5 other properties that are going through at the same time, so all this gets...inaudible...so...

Mr. Foltz: Okay, anyone else like to address Council this evening?

Mr. Osborne: My name's Chuck Osborne, 307 Fairview Street S.E., North Canton, Ohio. Two weeks ago on June 11, 2007, I questioned before this council the decision of the North Canton CIC to purchase a ½ acre property abutting the rear parking lot of Abbott's Bridal Shop for additional parking needs to benefit private business. The need for expanded parking at the rear of Abbott's is the only hurdle to the property owner for leasing 11,000 square feet of office space to the Service and Support Administration of the Stark County Board of MRDD and bringing 70 jobs to the city. The four-year lease, with an option to renew for one year will generate \$428,450 for Mr. Randall McNurlin. In Mr. McNurlin's own words before the CIC, this was net revenue. The CIC will be expending \$115,000, not including engineering and other soft costs, for the purchase and development of the ½ acre parking lot. These are funds that

were removed from North Canton's General fund and given to the CIC. The CIC will recoup from Mr. McNurlin \$1.00 per year over the five-year span of the lease and be left owning a landlocked parking lot with no value at the end of the lease. This handout of what was once taxpayer dollars to benefit the private business interests of Mr. McNurlin is not the first time the owner of Abbott's Bridal Shop has benefited from taxpayer assistance. I call it a part of the city's genealogical history. Paul Harvey would call it "The Rest of the Story." I have learned the following from a search of city records: In 1998, the City of North Canton purchased the property on which Abbott's Bridal Shop is now located for \$180,000 and paid \$9,600 to clear several structures from the property. These figures do not include appraisal costs, survey costs and other soft costs required in the purchase of property. The property consisted of 1.51 acres. The city subsequently sold 1.26 acres to Mr. McNurlin and carried a no-interest note on the sale of the property for him. The North Canton City Council passed the legislation to sell the property on "an emergency" on December 14, 1998. In city council minutes from the meeting Councilmember Jon Snyder is quoted as saying "...it's a win, win situation for the city. And my compliments to Mr. Sumser for putting it together." After months of delays on the part of Mr. McNurlin to finalize the purchase of the property, the following comments were made by councilmembers in a council meeting held on May 10, 1999. Councilmember Tim Morrow stated "...We have-you know there's a valuable piece of Main Street property...we spent taxpayer dollars to tear this down...." Mr. McNurlin subsequently finalized the purchase of the property on July 14, 1999. After Mr. McNurlin received a "moving credit" of \$65,000 from the city business - from the city for business moving expenses, his net cost for the purchase of the property was \$50,000. Mr. McNurlin became owner of a valuable piece of Main Street property for a fraction of its true costs at the expense of North Canton taxpayers. At the May 10, 1999, council meeting, Councilmember Doug Foltz is quoted as saying "...It's a sweetheart deal for him...." The vote by council, on an emergency, to sell the property to Mr. McNurlin was unanimous. Is that any surprise? Yes, Mr. Foltz, it indeed was a sweetheart deal. How many other business owners would like to acquire frontage on Main Street for a fraction of its costs? The city used the rear portion of the property, approximately 1/4 of an acre, to locate a water storage tank that water distribution studies have identified as a less than ideal location for a water storage tank. The poor location for this South Main Water Storage tank is due to low ground elevations that have been acknowledged only recently by this administration. I thank Mr. Wise for his candor in this regard as past city administrations have denied there are problems. As we all know from grade school, water does not flow uphill. Why city council approved this location for construction of a water storage tank does not speak well for their grasp of basic principles of physics. The construction of the water storage tank at this location received unanimous approval from City Council. The owner of Abbott's also received waivers for sewer frontage fees and water tap-in fees totaling \$5,021.00. Additional zoning variances were given including reduced parking size requirements. In 1999, the City of North Canton gave Mr. McNurlin a five-year, fifty percent abatement of taxes on the Abbott Bridal Shop property. Unfortunately, the city was not able to provide any documentation as to the amount of taxes that were abated. From the outset, it appears from the records that Mr. McNurlin failed to comply with the terms of the original five-year tax abatement. That abatement was amended to a three-year, fifty percent abatement of taxes. And again, I was unable to determine whether the terms of the amended tax abatement were ever met as well, but as we have seen from ongoing tax abatements, the tax exemption continues whether there is compliance with the terms of the agreement or not in the City of North Canton. It is interesting to note that the - that the city also could not provide any kind of estimate in terms of income taxes that have been collected from business activity from this property yet the city was quick to provide estimates of the income tax that would be collected if MRDD relocated to the office space located below Abbott's Bridal Shop. In summary, the ... assistance to the owner of Abbott's Bridal Shop has ranged from sweetheart deals to outright giveaways at taxpayer expense. These actions, past and present, are a blatant slap in the face for North Canton taxpayers who are subsidizing financial gain for private interests. Furthermore, other business interests throughout the city do not receive the same corporate charity that has been lavishly showered on Mr. Randall McNurlin. At 1280 South Main Street, the business owner has received the following: deep discounts for purchase of Main Street property, waivers of fees, no interest loans at taxpayer expense, exemption of property taxes on commercial property despite noncompliance with the terms of the agreements, and now, free use of property and property improvements at the expense of others. All of these giveaways are at taxpayer expense and create unfair advantage between businesses that operate without handouts. None of this speaks well of city leaders who promote the city in this manner. It is a sad thing to watch the abuse of public monies in this manner. This is North Canton's past practice and it continues today. Something is wrong. Thank you.

I have no interest in the building itself or Mr. McNurlin's property, nor have I ever had an interest in Mr. McNurlin's property and relative to where Mr. Osborne's trying to take this is when this came up about the jobs and MRDD, I went to Mr. Repace and Mr. DeOrio, explained the situation and asked them to take it, to which time I did give it to Mr. Bowles and I stayed completely out of it, so that there is no compromise or no integrity or anyplace that it was said that I crossed the lines of ethics. And prior to that, when Mr. McNurlin received that property, I was not in that building and we can thank Director Sumser who was the quasi Economic Development Director, those were things that he gave Mr. McNurlin and to answer his question, I think the one tenant alone had near a million dollar payroll when the - when he did finally leave there, and he was removed from the CRA by a vote of Council because he did not start the property in a timely manner. He did comply to all other aspects, both payroll employees and all qualities of the law. So I think Mr. Osborne, as usual, he has his facts somewhat distorted, but I just wanted to clear that up, that at no time did I compromise my integrity, or did I cast a vote where I had any interest in any property that would make it an ethics violation, and I appreciate you allow me say that.

Mr. Foltz: Okay, appreciate your comments, Member Snyder. Thank you. Member DeOrio?

Mr. DeOrio: Yes, I just wanted to say that I think since our last meeting, I had the pleasure and the opportunity to attend a ward meeting in Councilman Lane's ward at his invitation. I really like the — the neighborhood meeting programs that he's done over the years. I think that's — I think it's a real testament to — to service of his — of his constituents and I appreciate him giving me an opportunity to talk city finances with — with his residents.

Mr. Lane: Appreciate you coming, thank you.

Mr. Foltz: Okay, Member Hines? Mrs. Hines: It's the EMT/P...

Mr. Lane: inaudible...

Mrs. Kalpac: EMT-P/Firefighter.

Mrs. Hines: Slash firefighter. That's the whole term. They – they did have 15 people sign up to take the test. Thirteen took the test, ten passed the test, and the Civil Service Commission has certified the top six.

Mr. Foltz: Very good. Mrs. Hines: That's it.

Mr. Foltz: Alright, thank you. Member Repace.

Mr. Repace: Through a meeting last week with TTI, they have given me final permission to have that World War II Veterans Memorial plaque that hangs on the Hoover building donate to the city. But I will say this, I'd like to get something done with it. I'd like to get it done soon, this summer. I don't know how you — we intend to mount it or where we would put it, but we need to get on it, move quickly on it because I do not want to see something — that sign — that plaque disappear somewhere. If we're going to drag our feet doing something with it, then I will make other arrangements and have it — donate it somewhere else. But I have had final permission. So with that, Administrator Wise, I would like you and I to do something with that and get it moving because I don't want — I don't want to see that thing wind up disappearing if we get a new tenant in that building, which could very easily happen. And I'm not going to wait a year — year and a half from now, 'cause we do have a tendency moving very slow in this city on some things. Also, you mentioned the — the New England water problem. What is being done? It's not a \$25,000 project, it's not a \$300,000 project. It's a minimal cost. The residents are — are upset. The problem's getting worse. It's an easy fix, what are we doing?

Mr. Wise: Well at this point, my suggestion is we have a meeting. There's a resident out there that sued the city several years ago over what happened. There was a settlement of that suit. I — I want to know what the settlement of that suit was, and then have a meeting. We have some ideas on what to do but it — it's going to have to involve those individuals because the last time there was some indication that something was going to happen, they indicated that if you come out to dig, bring the police, so I – I don't want to get into some confrontation with anybody out there when someone from the city goes out to do any work.

Mr. Repace: Well no matter what you do, you're going to have a problem with that resident, number one. Number two, the problem last time was the city promised before anything was done, they would have a follow-up meeting, and the follow-up meeting did not take place, and that's what the resident was upset about.

Mr. Wise: ... Inaudible...

Mr. Repace: But you - no matter what's done out there, you're going to have one resident is going to complain. If you do something, you're going to complain, if you don't he's going to complain. But something has to be done because there's a whole bunch of other residents that are disturbed.

Mr. DeOrio: ls - if l may interject - is the - is the resident that ls - that is the - is the problem, is this the one that has...planted trees in the city's easement?

Mr. Repace: yes.

Mr. DeOrio: Okay. You know, so yeah, there are some issues there that — that need to be addressed if that is our easement and we've — and somebody's planting trees in it, and we're trying to do a project then I think that's something that the — the law department might ultimately have to get into, but you know, really what we have to come down to is serving the greater good. I mean, there are more people in here in need of relief than the one who isn't. And I'm not sure you know, why that is such an ordeal. I've been out to your — that place, I've walked that property from you know, the northern New England drive all the way down to where it hits the creek. The city has expended a ton of money, tens of thousands of dollars, putting in a larger...

Mr. Foltz: Detention basin?

Mr. DeOrio: No, help - Engineer, help me out with that...

Mr. Lane: Culvert?

Unidentified: Storm sewer?

Mr. DeOrio: A what? Unidentified: Culvert?

Mr. DeOrio: What's the – the water has to go under the road and has to go through a big.... Unidentified: Culvert will work.

Mr. DeOrio: Culvert and we've put in a larger one to accept more capacity of water to get the water out. Well, that — that's not the problem. The problem is that the water's not flowing because it doesn't have any momentum, it kind of bubbles up through the — from the — the pipe that comes down into that area has got three foot of sediment in it and got a two inch opening and the water just kind of gurgles up. And then it doesn't have that momentum to keep it going so it is — seems to be a very simple solution and one that is, you know, desperately needed. I'm sure that the ward councilman wants to comment...inaudible...

Mr. Repace: I'll tell you, this Mr. Engelman was out last night, digging the front of that grate of the easement that runs through his property, 'cause it was probably three...3/4's covered. So he was out there cleaning the front of that last night. Something has to get done. This is just going to continue to get worse and the main - once it's cleaned out, the main problem should be over because the silt from construction is over. The – the allotment is full now. So you're not going to have the sand and the dirt and so forth running through there as you had during the construction period. And you're - you're well aware of what's going on there, Doug.

Mr. Lane: Very much. As a matter of fact ...

Mr. Repace: So let's get something done.

Mr. Lane: Earle, Earle had mentioned, and maybe this isn't the right place to bring it up, but we were talking about a piece of equipment that you could use, that we could get this done as opposed to having to farm it out, we could save some money and get to it....

Mr. Wise: Well the city crew could do it, there's a \$800 bucket that allows them with the new Track Hoe that was purchased last year, that allows the bucket to tilt and it then makes it easier to - to make a drainage ditch with the power equipment as opposed to having a number of city workers out there doing it by hand. Mr. Lane: That's something that you just need our approval to buy, or can you buy it?

Mr. Wise: Well I don't know that we have any money in the budget to buy it, but..

Mr. Repace: Rent it. Let me offer a suggestion here. Why don't we put a plan together, have a meeting with the residents in that area like we did whenever it was...

Mr. Repace: You're telling me.

Mrs. Magel: The – something that our project that's going to come up on – on my committee. And it's going to come up on the 2<sup>nd</sup>, and we're going to have to make a decision for the 9<sup>th</sup>. Jon, you're on my committee, and Susie you're on my committee. Please call me, this is important, it's going to take some time, and I would ask the Finance Committee to call me, anyone else. It's a serious project, you call me from the ocean.

Mr. Foltz: I'll call you, I'll call you before I leave. How 'bout that?

Mr. Lane: ...inaudible...water, he's going to find water...

Mrs. Magel: Alright the - do you have a map, Mr. Benekos that you'll be giving me?

Mr. Benekos: Yes.

Mrs. Magel: Okay. And I'll be sharing that with my fellow council members. Because I believe you want this moved on by the 9<sup>th</sup>?

Mr. Benekos: Correct.

Mrs. Magel: Okay. Second thing is leading up to a third thing. On – I believe there's a resolution in the works that was December 2004. Mr. Snyder: and they wanted a conditional use, they would have to go to Planning and apply for that. It does not open Office Business to drive-throughs. It's only done parcel by parcel as they apply.

Mrs. Magel: Well I was wondering, do you object to putting it back on committee so we could all talk about it again? July  $2^{nd}$ ?

Mr. Snyder: Well the problem that you have right now, you - it'll take six votes to overturn that. Those people paid \$660,000 for that acre of land and they need to move on that, that's the problem. I mean you can't be disingenuous as far as now saying to them that, you know, they paid - they've already paid I think the hospital for that land. They're waiting for approval and we need six votes to overturn that.

Mrs. Magel: I'm just asking if you mind putting it back on so... Mr. Snyder: No, I don't mind putting it back on for consideration.

Mrs. Magel: Council, we could talk about it again. Is that too late? July 2nd?

Mr. Snyder: No, I mean I have no problem with that, but I'm just saying what it is. But I don't – I don't know where – what the misunderstanding is. That's – that's a very simple thing.

Mr. Lane: Well I think part of it, to be honest with you if I could interrupt, 'cause I was asking some of the same questions last week, because I - the assumption that I got was that we were permanently changing what's in there. But being a conditional use we could do that because each time that somebody wants to bring something in the Planning Commission has a chance to look at it...

Mr. Snyder: That's right.

Mr. Lane: and either pass it or so - so in essence we're both right, in other words, we're doing . it for this one parcel...

Mr. Snyder: Right.

Mr. Lane: but it - it goes on it perpetuity until somebody else comes in to ask for that.

Mr. Snyder: Yeah, unlike ...

Mr. Lane: and I think that was where I was trying...

Mr. Snyder: if you recall back when that parcel was plotted, it was plotted Office Business because Aultman Hospital owned it, and it was their intention at that time to put...

Mr. Snyder: office buildings on there, which on the remaining acreage they...you know, but I'm sure the bank, when the bank purchased it, assumed because the remainder of the property is General Business B which permits that type of zoning. There is two banks out there already I think, one with a drive-through. Star or whatever it's called.

Mr. Snyder: Well you're only changing one designation.

Mrs. Hines: Well, we want - I mean, I think that's what - I've heard different things about whether we are or whether we aren't - what we're changing and I don't know it all well enough and I think that's...

Mr. Snyder: That's not a problem.

Mrs. Hines: what we need to discuss.

Mr. Snyder: But you're only -- you got to remember, you're only changing conditional use in one - in Office Business only, nothing else. Not in General Business B or anything below Office Business, which would be Parks and Institutions, but...

Mr. Foltz: Well, we can discuss it further.

Mrs. Magel: Yeah, we'll discuss that, Jon.

Mr. Foltz: And I don't know if Gene might be available...his situation or...

Mrs. Magel: No. Jon will not - Gene will not be available.

Mr. Foltz: Okay. Or Jim, you were part of that I'm sure at the Planning Commission, we can reflect more on the minutes of what their discussion so we're all better versed in what's happening with that area, within our - our zoning ordinances. Don't take lightly changing a zoning ordinance. I mean, that's something we should consider at all angles even though I know there's good intentions, so, that said, any other comments? I have one for Member DeOrio 'cause he's a numbers guy but I'm glad you put it on the record with the recycling grant, it is all about the tonnage. It's all about the tonnage in 2009 and hopefully Administration, we're going to bring something out here shortly for our residents about the additional yard waste program, that extra four weeks. But I was doing some figuring, on last year's recycling, and we - our yearly total last year was 925 tons. I think we're a little bit ahead of schedule this year, at least through the first quarter. But we anticipate 365 tons with that other 4 weeks. But what I like to look at is the bottom line as far as expenditure per ton and even though our residents are playing, excuse me, paying for the mixed co-mingle and the - the yard waste program, last year's program anyway. We know we're picking this year's 4 weeks up off of grant. Basically to recycle the newspaper and co-mingles costs us \$212 a ton. To recycle just the leaf yard waste, 'cause it was mostly leaves that late in the year, was \$153 a ton. To do the grass maybe with some leaves, the additional 4 weeks that we're putting on, is going to be \$91 a ton. So you can see the enormous payback per ton, if the projections hold true, I'm excited to see what we're going to do this fall. I'm just - just giving you some information so we'll see when, you know, proofs in the pudding, we'll see when we do it, but that said, any other comments from Council or Administration?

Mr. DeOrio: If - Mr. President, if I might ask Administrator Wise, do we have any more of the recycle bins?

Mr. Foltz: Should have them.

Mr. Wise: They're on order, I don't know if they've come in last week or not.

Mr. DeOrio: Okay.
