## CALL TO ORDER:

The meeting was called to order at 6:57 p.m. by President of Council Doug Foltz.

The following members of Council were present for the public hearing: DeOrio, Foltz, Hines, Lane, Magel, Repace, Snyder. Also present were: Director of Administration Wise, Director of Law Pusateri, Director of Finance Herr and City Engineer Benekos.

Notice is hereby given that a public hearing will be held by the Council of the City of North Canton on Monday, March 6, 2006 at 6:45 p.m. in the Council Chamber at North Canton City Hall. The purpose of the hearing will be to establish zoning for the recently annexed Martinez/East Maple area. The North Canton Planning Commission, at their January 4, 2006 meeting, recommended that this area be zoned R-70, Residential Single Family.

Mr. Foltz: We're running late, but I think we'll just push through the public hearings and postpone the committee meeting overall. So, at this time, we'll call the public hearing for zoning of the recently annexed Martinez/East Maple area. The North Canton Planning Commission, at their January 4, 2006 meeting, recommended that this area be zoned R-70, Residential Single Family. Is there anybody here to address Council on that zoning issue? Once again, anybody here to address Council on the zoning issue of the Martinez/East Maple area.
