CALL TO ORDER:

The public hearing was called to order Monday, November 7, 2005 at 6:50 p.m. by President of Council Jon Snyder.

The following members of council were present for the public hearing: Foltz, Kiesling, Lane, Lindower, Peters, Sarbach and Snyder. Also present were: Mayor Rice, Director of Administration Miller, Director of Law Pusateri, Director of Finance Herr and City Engineer Benekos.

Notice is hereby given that a public hearing will be held by the Council of the City of North Canton on Monday, November 7, 2005 at 6:45 p.m. in the Council Chamber at North Canton City Hall.

The hearing is with regard to a proposed amendment to Section 1137.03 SCHEDULE OF PERMITTED USES of the North Canton Zoning Ordinance.

The Planning Commission, at its September 7, 2003 meeting, recommended that the following similar use category, be added as a conditional use in GB-A district and a permitted use in GB-B district

(d)(17) Pet services such as grooming, boarding, pet daycare, etc.

Final action thereon, according to Law, will be taken by the Council of the City of North Canton subsequent to the date of said public hearing.

Mr. Snyder: This is hearing is in regard to a proposed amendment to Section 1137.03 Schedule of Permitted Uses in the North Canton Zoning Ordinance. The Planning Commission recommended that a similar use category be added as a conditional use in GB-A and a permitted use in GB-B. That being subsection (d) Article (17), pet services such as grooming, boarding, pet daycare, etc. Is there anyone in the audience that wishes to speak in favor of this? Is there anyone in the audience wishing to speak against this? It is my understanding that the lady is not ...inaudible... to come. Is that true? Something to do about gas.

Mrs. Kiesling: Correct.

Mr. Snyder: I don't understand. What does that have to do with trimming the dogs?

Mrs. Kiesling: She doesn't want to spend the money to bring the business down here. She doesn't live here ...inaudible...

Mr. Snyder: Oh, okay. And maybe you can bring us up to speed on that. I'm not...

Mr. Snyder: Well this will - and this will - this will make it a conforming use and then she won't be - that person won't in violation.


